Questions & Answers

Q: We have ELPA trained staff that go to different buildings to help with testing. Currently, we set them up with the building for the entire district as well as each individual school. Is there a better way to give them access at all schools?

A: Currently each permission (school, district level) needs to be added individually within TIDE.

Questions & Answers - SEED

Q: Will you be adding a checkbox for "SEED" and "Interim Assessments" training on the TA assurance form?

A: No.

The SEED Survey is non-secure. There is no need for an assurance form because there is no need to maintain item security.

The Interim Assessments are semi-secure, meaning they are sharable at the classroom and building level (but not with the public).

- This information is covered in Training Module 8 Interim Assessments
- Interims may need to be administered prior to yearly TA training.
 - Therefore, ODE did not want to create an additional step for DTCs to collect TA Assurance Forms on multiple occasions.



Honoring Student Proficiency on the HS ELPA

Waiver Request - Public Comment

The public comment period for our *Honoring Student Proficiency on Oregon's High School ELPA Summative* waiver request will be open from Tuesday, December 7, 2021 through Friday, January 14, 2022.

Remote Testing Update

Remote Test Administration

- ODE plans to make remote test administration available for all general summative assessments in the spring 2022 school year (ELA, math, science, SEEDS, and ELPA)
- Family impact and item security threat concerns were **not** substantial based on other state experiences with remote testing (e.g., CA, CT, ID)
- Oregon's virtual charter schools and district online programs, as well as students experiencing health or safety concerns need accessibility

Remote Test Administration – Testing Window

- **Remote Testing Window:**
 - **ELPA (4/19 - 4/29)**
 - **OSAS ELA, Math, Science, SEED (4/19 - 6/3)**
- Remote testing is being made available of necessity (*e.g. online, virtual, health needs*); it is not a mode that is promoted for use with students who are attending in-person instruction.

Remote Test Administration - Priorities

Order of Priority

A student's assessment participation will be administered in alignment with their primary instructional model.

- a. If a student is attending a school in person, they will take their summative assessment in person.
- b. If a student is attending a virtual or online school, they will be eligible to take their summative assessment remotely. *(Parents/Guardians have the opportunity to request their child take their summative assessments in person, if they choose.)*

Braille and the Oregon Extended are not currently available options for remote administration

Remote Test Administration Video Enabled

- CAI **requires** parent permission for remote testing and use of video-enabled during remote testing. Remote Testing must be activated in TIDE at the student level.
- ODE has adopted a hybrid approach to video-enabled remote testing:
 - Student participates with **video-enabled**
two-way communication with TA: audio and chat, screen-sharing, student can toggle camera on/off
 - Student participates with **video-disabled**
two-way communication with TA: chat only

DTC/STC/TAs will need to indicate in TIDE which students have permission for webcam use

A: *ODE's goal is to have all materials (parent resources, DTC/TA Training materials and DTC/TA support resources in place prior to the January 3, 2022.*

Questions & Answers – Remote Training Certification

Q: For the Remote Training Admin Certification, will TAs need to wait to get their secure login before they can access/complete this training?

A: *Yes, the Remote Certification Course is connected to the TIDE System. Once a DTC/TA completes the training course the system will automatically activate the remote testing feature in the DTC/TA's TIDE account.*

The Remote Certification Course outlines the technical functionality of administering a remote session and how to engage with students.
