1. Are there any updates on what will happen with Essential Skills after the current suspension expires?
 - a. There are no updates to share at this time.

2. What should I do if a student seems to have incorrect ELPA Proficiency Met values in the Test Information Distribution Engine (TIDE)?

Accountability and Reporting

3. How are denominators generated when calculating performance for the statewide school report cards?
 - a. The official assessment summaries are found in the Achievement Data Insight application. In the assessment student performance validations, you will find the participation denominator in the RC Summary tab includes students reported as resident in Third pd ADM as enrolled on the first school day in May. The performance denominator used on the At-A-Glance reports includes students reported as enrolled for a full academic year meaning they are enrolled on the first school day in May and their calculated ADM amount is greater than .5 in the collection.
 - b. There is also an AGR Summary tab in the assessment student performance validations that is posted on the public Assessment Group Reports webpage. The participation denominator in this calculation matches the denominator used in the RC Summary tab. However, the performance denominator includes students reported as enrolled on the first school day in May whether or not the student was enrolled for a Full Academic Year. First year English learners are included in the participation calculations if reported as enrolled on May 1, and excluded from the performance calculations.

4. If a test is flagged under the new crisis alert processing system, will I see a new crisis alert each day that the student makes changes anywhere in the test, or only at the end of each day they make changes to the specific item that has the concerning language?
 - a. A new crisis alert is only prompted by changes to the response containing the concerning text. Changes elsewhere in the test that do not modify the response with the concerning text will not prompt a new crisis alert.
