

Oregon CLSD Eligibility Ranking and Preliminary Allocation Tool

Overview: This tool is designed to support school districts interested in applying for the Oregon Comprehensive Literacy State Development (CLSD) grant in understanding their eligibility status and planning their application accordingly. **ODE anticipates awarding 30-50 districts out of the 100 eligible to apply.**

This document outlines the following components:

- **Eligibility Status-** Identifies whether a district is eligible to apply for the Oregon CLSD Grant.
- **Eligibility Ranking-** Districts with an eligibility ranking closest to 1 will have the highest priority for funding. Final grant awards will be determined based on a combination of the district eligibility ranking (50%) and the narrative application score (50%).
- **Preliminary Allocation-** Districts will budget for this amount during the CLSD Grant application process. Final awards may change based on grant priorities, funding levels, and/or to ensure equitable distribution of funding for eligible applicants.
