

## **Division 22 Requirements Charter School Matrix**

Public charter schools are required to comply with ORS Chapter 338, which includes a list of applicable statutes and rules in ORS 338.115, as well as any other requirements outlined in the charter school contract, policies, or other agreements (e.g. grant agreements). The regular assurances in Division 22 under OAR 581-022-2305 do not apply to public charter schools. This is a requirement of school districts. As public charter schools are reporting out to their sponsoring districts, the following matrix can be consulted:
