FINDINGS OF FACT

(1) On January 20, 2011, Sydney Brewster, Attorney at Law, filed a request for due process hearing with the State Superintendent of Public Instruction on behalf of Student and Parent.

(2) On March 30, 2011, the Office of Administrative Hearings received a letter from Ms. Brewster, dated March 17, 2011, stating that the parties had reached a settlement agreement through mediation. Ms. Brewster therefore requested that the due-process hearing be cancelled. Because no issues remain to be resolved, a contested case proceeding no longer is required.

ORDER

The January 20, 2011 request for a due process hearing has been withdrawn and the case is dismissed with prejudice.
