#### FINDINGS OF FACT

- (1) On September 11, 2012, Parents filed a request for a due process hearing. On September 12, 2012, the Oregon Department of Education referred the request to the Office of Administrative Hearings.
- (2) A Pre-Hearing Conference was held on October 12, 2012. Ross Day represented Student. Richard G. Cohn-Lee represented the Jackson County School District. A due process hearing was scheduled for November 13-15, 2012. A second Pre-Hearing Conference was held on October 29, 2012. Mr. Cohn-Lee appeared on behalf of the Jackson County School District. No one appeared on behalf of Student. Mr. Cohn-Lee represented that the matter had settled at mediation. Mr. Day subsequently provided a request for dismissal of Parents' due process complaint.

#### **ORDER**

Parents' request for a due process hearing has been withdrawn and the case is dismissed with prejudice.
