## FINDINGS OF FACT

- (1) On October 21, 2013, Ross Day, Attorney at Law, filed a request for a due process hearing on behalf of Parents and Student, with the State Superintendent of Public Instruction, alleging that the District had failed to provide a free and appropriate education for Student as required under the Individuals with Disabilities Education Improvement Act of 2004 (IDEIA), 20 USC §§ 1400 et seq. The parties, having made a joint request to go to mediation, waived the resolution sessions. Therefore, the resolution period ended with no resolution session having been held
- (2) The matter was referred to the Office of Administrative Hearings (OAH) on October 21, 2013, to be set for hearing and was assigned to Senior Administrative Law Judge (ALJ) A. Bernadette House. ALJ House convened a pre-hearing teleconference on November 22, 2013. Mr. Day appeared on behalf of Parents, who were also in attendance. Rich Cohn-Lee, Attorney at Law of the Hungerford Law Firm, appeared on behalf of District. The parties informed ALJ House that they were working to schedule mediation which they hoped would occur in December 2013. Because the parties were working with a mediator to set a date for mediation and were working towards resolution of the matter, the parties' joint request to extend the 45-day deadline to a date certain was granted. The hearing was set for January 21-23, 2014, final order due on or before March 28, 2014.
- (3) At the parties' request, ALJ House convened a teleconference on December 27, 2013. The parties jointly request to reschedule the hearing to allow for mediation, which was scheduled for January 13, 2014. The request was granted and the hearing was rescheduled for March 17-19, 2014. Relevant deadlines were also reset. The date certain for the Final Order was rescheduled to May 16, 2014.
- (4) On January 21, 2014, Mr. Day informed the OAH that the parties had reached an agreement in mediation and that Parents were requesting to withdraw the hearing request of October 21, 2014.
- (5) Accordingly, based on Parents' request, through counsel, and representation that the parties have settled by agreement the issues raised in the October 21, 2013 due process hearing request, a contested case proceeding is no longer required. The matter will be dismissed with prejudice and the hearing scheduled for March 17-19, 2014 will be removed from the calendar.

#### **ORDER**

The hearing request of October 21, 2013, regarding issues raised by Parents and Student against Colton School District, having been withdrawn, is **DISMISSED** with prejudice.
