#### FINDINGS OF FACT

- (1) On February 3, 2015, Parents, on behalf of Student, filed a request for a due process hearing (hearing request) with the Oregon Department of Education (ODE) alleging District had failed to provide a free and appropriate education to Student as required under the Individuals with Disabilities Education Improvement Act of 2004 (IDEA).
- (2) On February 4, 2015, ODE referred to the Office of Administrative Hearings (OAH) for a due process hearing. Senior Administrative Law Judge Bernadette H. Bignon was appointed to conduct the due process hearing.
- (3) ALJ Bignon convened a pre-hearing teleconference on March 10, 2015. Mother appeared *pro se* and represented Parents and Student. Rich Cohn-Lee, Attorney at Law of the Hungerford Law Firm, appeared on behalf of District. The parties informed ALJ Bignon that a resolution session had not been held because the parties had begun mediation during the resolution period. Parents had thereafter withdrawn from mediation but no resolution session was held before the end of the resolution period. The parties' joint request to extend the 45-day deadline, to allow for preparation for hearing, to a date certain was granted. The hearing was set for May 18, 2015 through May 20, 2015 with the final order due on or before July 24, 2015.
- (4) By email dated March 25, 2015, Parents' notified ALJ Bignon that they wished to withdraw their hearing request of February 3, 2015, in order to focus on family emergencies.
- (5) Accordingly, based on Parents' request to withdraw the February 3, 2015 due process hearing request, a contested case proceeding is no longer required. The matter will be dismissed without prejudice and the hearing scheduled for May 18, 2015 through May 20, 2015 will be removed from the calendar.

### **ORDER**

The hearing request of February 3, 2015, regarding issues raised by Parents and Student against Yamhill-Carlton School District, having been withdrawn, is **DISMISSED** without prejudice.
