# FINDINGS OF FACT

- (1) On January 15, 2016, Diane Wiscarson, and Elizabeth Polay, Attorneys at Law, of Wiscarson Law, filed a request for a due process hearing (hearing request) on behalf of Parent and Student with the Oregon Department of Education, alleging that Douglas County School District 4 (District) had failed to provide a free and appropriate education for Student as required under the Individuals with Disabilities Education Improvement Act of 2004 (IDEIA), 20 USC §§ 1400 et seq. The parties jointly waived resolution in favor of mediation. The resolution period ended on February 13, 2016 with no resolution session having been held.
- (2) The matter was referred to the Office of Administrative Hearings (OAH) on January 19, 2016, to be set for hearing and was assigned to Senior Administrative Law Judge (ALJ) Bernadette H. Bignon. ALJ Bignon convened a pre-hearing teleconference on February 18, 2016. Ms. Polay appeared, on behalf of Parent and Student. Rich Cohn-Lee, Attorney at Law, appeared and represented Douglas County School District 4 (District). The parties informed ALJ Bignon that mediation had been scheduled for March 7, 2016. Because the parties had scheduled mediation and were working towards resolution of the matter, the parties' joint request to extend the 45-day deadline to a date certain was granted. The hearing was set for April 19-21, and April 25-26, 2016, final order due on or before July 7, 2016.
- (3) On March 8, 2016, Ms. Polay, on behalf of Parent and Student, informed the OAH that the parties had reached an agreement in mediation and that Parent was requesting to withdraw the hearing request of January 15, 2016 with prejudice.
- (4) Accordingly, based on Parent's request, and representation that the parties have settled by agreement the issues raised in the January 15, 2016 due process hearing request, a contested case proceeding is no longer required. The matter will be dismissed with prejudice and the hearing scheduled for April 19-21 and April 25-26, 2016 will be removed from the calendar.

## **ORDER**

The hearing request of January 15, 2016, regarding issues raised by Parent and Student against Douglas County School District 4, having been withdrawn, is **DISMISSED** with prejudice.
