FINDINGS OF FACT

- (1) On April 24, 2018, Parents filed a request for due process hearing with the State Superintendent of Public Instruction on behalf of J.L. (Student). The Department of Education referred the hearing request to the Office of Administrative Hearings (OAH). The OAH assigned Administrative Law Judge (ALJ) Jill Marie Messecar to preside over the hearing in this matter.
- (2) On May 18, 2018, ALJ Messecar conducted a prehearing conference (PHC) by telephone. Taylor Richman, attorney at law, appeared on behalf of the Portland School District 1J (the District). No one appeared to represent Student or Parents. At the prehearing conference, the District requested the 45-day deadline for issuing the Final Order be extended to a date certain, in order to participate in a IEP meeting scheduled for June 4, 2018. ALJ Messecar granted the request and scheduled the hearing for August 22-23, 2018 and the final order to be issued on September 28, 2018. A second PHC was scheduled for June 13, 2018.
- (3) On June 13, 2018, ALJ Messecar conducted the second PHC by telephone. Taylor Richman, attorney at law, appeared on behalf of the District. Foster parent, Mr. Lufkin, appeared to represent Parents and Student. Mr. Lufkin explained that the parties were still waiting on a placement decision. The parties discussed the hearing scheduled for August 22-23, 2018 and the parties asked that hearing be moved to September in order to prepare for hearing. ALJ Messecar granted the request and scheduled the hearing for September 18-19, 2018 and the final order to be issued on November 7, 2018.
- (4) On July 27, 2018, Mr. Lufkin notified the OAH that the parties had settled the matter and requested withdrawal of the hearing request without prejudice.

ORDER

The April 24, 2018 request for a due process hearing in the above-captioned matter has been withdrawn. The case is dismissed without prejudice.

Because Parents have withdrawn their hearing request, a contested case hearing is no

longer necessary and the hearing currently set for September 18-19, 2018 is cancelled.
