#### **HISTORY OF THE CASE**

- 1. On December 13, 2019, Dr. Kimberly Sherman, attorney at law, filed a Due Process Complaint with the Oregon Department of Education (ODE) on behalf of Student I.S. and Student's parent, against Eugene School District 4J (District). ODE subsequently referred the request to the Office of Administrative Hearings (OAH). The OAH assigned the case to Administrative Law Judge (ALJ) Jessica E. Toth for hearing.
  - 2. On January 14, 2020, the parties participated in a telephonic prehearing conference.
- 3. On February 4, 2020, the parties participated in a second telephonic prehearing conference.
- 4. On February 20, 2020, Dr. Sherman notified the OAH, via email which included Eugene School District 4J legal counsel Joel Hungerford and Richard Cohn-Lee, that the parties had reached a final resolution. On February 24, 2020, Dr. Sherman submitted to OAH and counsel for the District a Motion to Dismiss requesting that OAH case number 2019-ABC-03382 be dismissed with prejudice.

## **ORDER**

The December 13, 2019 Due Process Complaint in the above-captioned matter is DISMISSED with prejudice and all upcoming dates associated with the matter have been vacated by the OAH.
