#### FINDINGS OF FACT

- 1. On March 26, 2021, attorneys Diane Wiscarson and Taylar Lewis filed a Request for Due Process Hearing with the Oregon Department of Education (ODE) on behalf of Student and Parents. On March 9, 2021, ODE referred the request to the Office of Administrative Hearings (OAH). The OAH assigned the case to Administrative Law Judge (ALJ) C. Meerdink.
- 2. On April 26, 2021, ALJ Meerdink held a prehearing conference (PHC), with Ms. Wiscarson and Ms. Lewis representing Student and Parents. Mother also participated in the PHCs. Attorney Elizabeth Polay represented the School District. Brian Baker and Mary Mertz also participated on behalf of the District. During the PHC, ALJ Meerdink scheduled the hearing for August 16 20, 2021.
- 3. On July 29, 2021, ALJ Meerdink held a second PHC, with Ms. Wiscarson and Ms. Lewis representing Student and Parents. Mother also participated in the PHC. Ms. Polay represented the School District. Mr. Baker also appeared for the District. At the PHC, ALJ Meerdink denied a request to reset the hearing and denied the district's motion to compel discovery.
- 4. On August 16, 2021, Chief ALJ John Mann held a PHC, with the attorneys present. CALJ Mann informed the parties that the hearing was being rescheduled due to ALJ Meerdink becoming unavailable, and rescheduled the hearing for November 17-19, 22-24, and 30, 2021.
- 5. On November 3, 2021, Ms. Lewis emailed the OAH and District stating that the parties had settled the matter, and requesting that the OAH dismiss the case with prejudice.
