# HISTORY OF THE CASE

On May 28, 2021, Ms. Diane Wiscarson and Ms. Taylar Lewis, counsel for Parents, filed a Due Process Complaint with the Oregon Department of Education (ODE) on behalf of Student A.A. and Parents. ODE subsequently referred the request to the Office of Administrative Hearings (OAH). The OAH assigned the case to Administrative Law Judge (ALJ) Jessica E. Toth for hearing.

On July 16, 2021, Parents' counsel filed a Second Amended Due Process Complaint, which became the operative complaint in this case. On July 1 and August 31, 2021, the parties participated in telephonic prehearing conferences. The ALJ set the matter for hearing from November 1, 2021 through November 15, 2021.

On October 27, 2021, Mr. Joel Hungerford, counsel for West Linn-Wilsonville School District 3J, notified the OAH via email which included Parents' counsel, that the parties had reached a final resolution. On November 1, 2021, Ms. Lewis notified the OAH, via email which included the school district's counsel, that Parent requested that OAH issue a final order dismissing the matter with prejudice.

### ORDER

The July 16, 2021 Second Amended Due Process Complaint in the above-captioned matter is DISMISSED with prejudice and all upcoming dates associated with the matter have been vacated by the OAH.
