FINDINGS OF FACT

(1) On March 15, 2022, Parent filed a request for due process hearing with the State Superintendent of Public Instruction on behalf of Student.

(2) On March 16, 2022, the Department of Education referred the hearing request to the Office of Administrative Hearings (OAH). The OAH assigned Senior Administrative Law Judge (ALJ) Joe L. Allen to preside over the hearing in this matter.

(3) On April 15, 2022, Parent notified the OAH that they wished to withdraw the hearing request based.

The March 15, 2022 request for a due process hearing has been withdrawn and the case is dismissed without prejudice.
