FINDINGS OF FACT

- (1) On March 31, 2022, Lincoln County School District (District) filed a request for a due process hearing with the State Superintendent of Public Instruction.
- (2) On April 1, 2022, the Department of Education referred the hearing request to the Office of Administrative Hearings (OAH). The OAH assigned Senior Administrative Law Judge (ALJ) Joe Allen to preside over the hearing in this matter.
- (3) On April 12, 2022, the District submitted a written request asking that a different ALJ be assigned to the matter. On April 19, 2022, the OAH granted the District's request and reassigned the matter to ALJ Carey Meerdink.
- (4) On May 26, 2022, the OAH reassigned the matter to Senior ALJ Alison G. Webster. On June 9, 2022, Student submitted a written request asking that a different ALJ be assigned to the matter. On June 17, 2022, the OAH granted Student's request and reassigned the matter to Senior ALJ Kate Triana.
- (5) On July 18, 2022, the District notified the OAH that it wished to withdraw the hearing requested based on resolution of all issues in the due process complaint.

ORDER

The March 31, 2022, request for a due process hearing has been withdrawn and the case is dismissed with prejudice.
