## FINDINGS OF FACT

- (1) On November 28, 2022, Parents filed a request for due process hearing with the State Superintendent of Public Instruction on behalf of Student.
- (2) On December 6, 2022, the Department of Education referred the hearing request to the Office of Administrative Hearings (OAH). The OAH assigned Senior Administrative Law Judge (ALJ) Joe L. Allen to preside over the hearing in this matter.
- (3) On April 17, 2023, Parents notified the OAH that they wished to withdraw the hearing request based on resolution of all issues in the due process complaint.

### ORDER

The Parent's request for a due process hearing has been withdrawn and the case is dismissed with prejudice.
