FINDINGS OF FACT

- (1) On March 10, 2025, Parent filed a request for due process hearing with the Oregon Department of Education (Department) on behalf of Student alleging a denial of a free and appropriate public education (FAPE) under the Individuals with Disabilities in Education Improvement Act (IDEA) by the Eagle Point School District (District).
- (2) On March 10, 2025, the Department referred the hearing request to the Office of Administrative Hearings (OAH). The OAH assigned Administrative Law Judge (ALJ) Alison G. Webster to preside over the hearing in this matter.
- (3) On April 14, 2025, ALJ Webster conducted a prehearing conference. Attorney Joel Hungerford represented the District. Attorney Anna Moritz represented Parent. The parties jointly requested to postpone the conference pending mediation, set for May 5, 2025. The ALJ granted the request.
- (4) On May 9, 2025, ALJ Webster convened a second prehearing conference. Counsel for the parties jointly requested to continue the prehearing conference for a few weeks to allow the parties additional time to discuss settlement. ALJ Webster granted the continuance request.
- (5) On May 30, 2025, ALJ Webster convened the continued prehearing conference. Counsel for the parties again jointly requested a continuance pending settlement discussions. The ALJ granted the continuance request.
- (6) On June 25, 2025, Parent's counsel filed with the OAH a Motion to Dismiss With Prejudice. Counsel advised that Parents had executed a written settlement agreement with the District resolving all issues in the due process complaint.

ORDER

Parent's March 10, 2025 request for a due process hearing has been withdrawn. The case DP 25-103 is dismissed with prejudice.


SERVICEMEMBERS' CIVIL RELIEF ACT
