FINDINGS OF FACT

(1) On April 1, 2025, Parents filed a request for due process hearing with the Oregon Department of Education (Department) on behalf of Student alleging a denial of a free and appropriate public education (FAPE) under the Individuals with Disabilities in Education Improvement Act (IDEA) by the St. Helens School District (District).

(2) On April 1, 2025, the Department of Education referred Parents' hearing request to the Office of Administrative Hearings (OAH). The OAH assigned Administrative Law Judge (ALJ) Alison G. Webster to preside over the hearing in this matter.

(3) On May 2, 2025, ALJ Webster conducted a prehearing conference. Attorney Taylor Kinch represented the District. Attorney Anna Moritz represented the Parents. The parties jointly requested to postpone the conference pending mediation, set for May 9, 2025. The ALJ granted the request and reset the prehearing conference to May 15, 2025.

(4) On May 12, 2025, Parents' counsel filed with the OAH a Motion to Dismiss With Prejudice. Counsel advised that Parents had executed a written settlement agreement with the District resolving all issues in the due process complaint.

ORDER

Parents' April 1, 2025 request for a due process hearing has been withdrawn. The above-captioned case is dismissed with prejudice.
