FINDINGS OF FACT

(1) On April 22, 2025, Parents filed a request for due process hearing with the State Superintendent of Public Instruction on behalf of Student.

(2) On April 22, 2025, the Oregon Department of Education (ODE) referred the hearing request to the Office of Administrative Hearings (OAH). The OAH assigned Senior Administrative Law Judge (ALJ) Joe L. Allen to preside over the hearing in this matter.

(3) On May 27, 2025, ALJ Allen convened a prehearing conference. Father appeared on behalf of Student. Attorney at law Andrea Schiers appeared for Portland School District 1J (District). At the conference, the parties informed the ALJ that they had reached an agreement regarding the single issue raised in the due process complaint. The ALJ reset the conference to June 10, 2025 to allow the parties time to finalize the settlement agreement.

(4) On June 10, 2025, ALJ Allen convened a second prehearing conference. Ms. Schiers appeared on behalf of the District. Father appeared on behalf of Student. At that time, Father notified the OAH that Parents wished to withdraw the hearing request based on resolution of all issues in the due process complaint. Father also submitted that request in writing to the OAH via email on the same date.

ORDER

The Parents' request for a due process hearing has been withdrawn and the case is dismissed with prejudice.
