ODE collected input regarding the use and distribution of amounts among activities to meet State priorities using a survey data collection. Stakeholders provided input during summer-fall 2019. ODE garnered input regarding the state priorities and activities from a number of stakeholder groups including the State Advisory Council for Special Education (SACSE), participants in Superintendents' and Special Education Administrators' Conferences, and leaders working in school districts and regional programs.

In addition to administrative costs, the amount retained by the State will be used to provide ongoing professional development and technical assistance to LEAs and regional programs serving students experiencing disabilities.

B. Significant Disproportionality²
