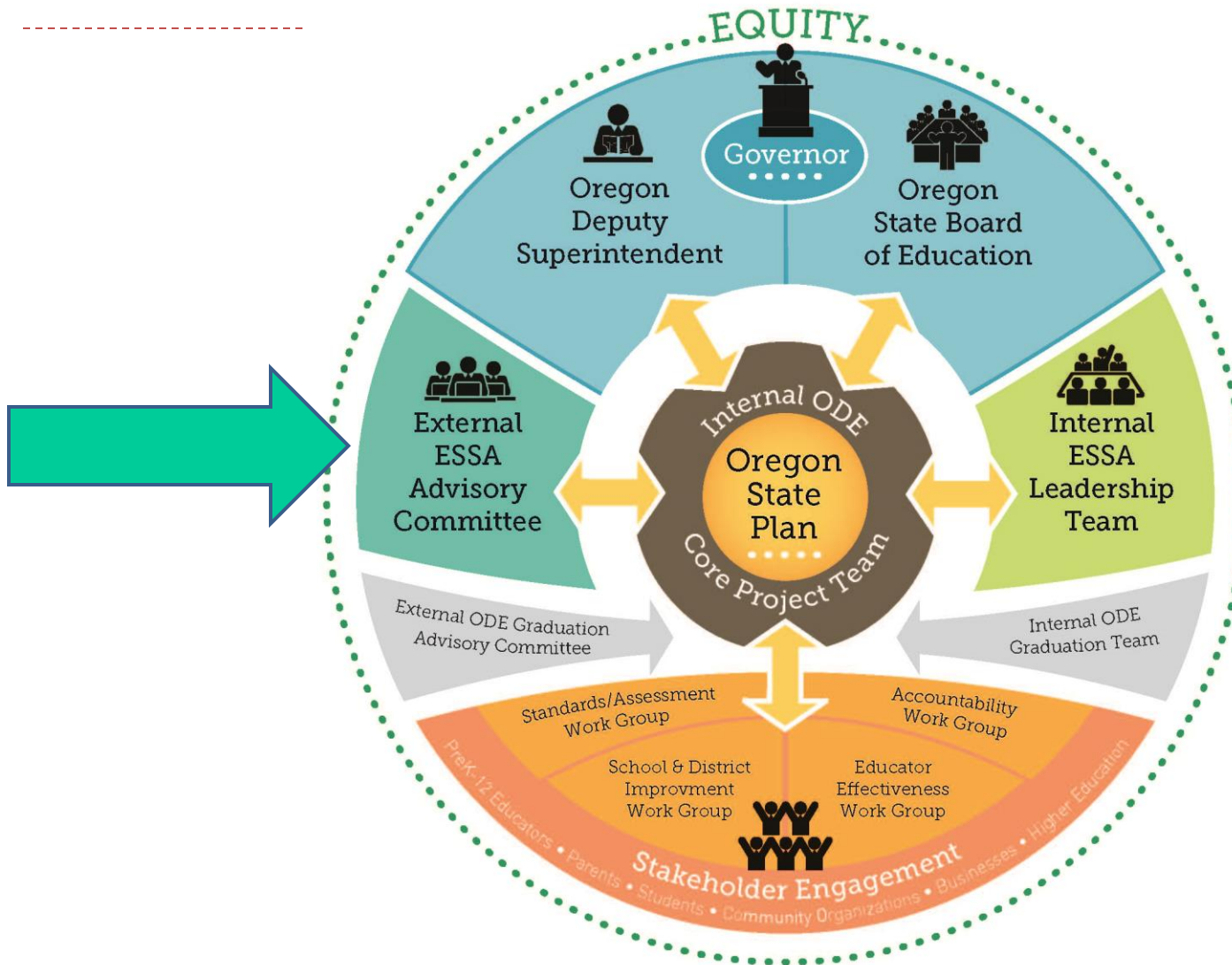

Where have we been?



- ▶ **Work Groups:** March – June 2016
 - ▶ Established and convened 4 technical work groups
 - ▶ Drafted recommendations for review
- ▶ **Stakeholder Engagement:** April – July 2016
 - ▶ Completed 13 community forums
 - ▶ Convened ESSA Advisory Committee
 - ❑ Equity must be foundational to Oregon's State Plan
 - ❑ A quality district system is stronger when based on multiple measures
 - ❑ Oregon's education goals and priorities must be integrated



Where are we now?

▶ **Refining Recommendations**

- ▶ Input needed on key decision points and recommendations where work groups did not come to consensus

▶ **Drafting Parts of the State Plan**

- ▶ ODE staff to begin to develop State Plan in order to solicit public input and feedback

▶ **Engaging Stakeholders**

- ▶ Develop a plan to meaningfully consult with tribes, communities of color, parents, educators, etc.

Where are we going?



July-Aug
2016

- Finalize work group recommendations and solicit feedback
- ODE teams draft state plan
- Targeted stakeholder engagement

Sept-Dec
2016

- Plan adjusted based on USDE rules
- Posted for public comment, stakeholder engagement continues
- Presented to State Board for review in Oct; for approval in Dec.

Jan-March
2017

- Plan adjusted based on stakeholder input
- Coordinate with Governor's Office & Chief Ed Office
- **Final Plan submitted by March 6**



Work Group Recommendations

Standards & Assessment



► Recommendations

1. Build local capacity for standards implementation and that supports a balanced assessment system
2. Pilot interim assessments for accountability purposes statewide
3. Allow for early testing in high school for students who meet state defined criteria
4. Explore options to reduce time necessary for current summative assessments
5. Explore options for high school flexibility
 - Seek options for individual student level choice
 - Evaluate potential assessment alternatives

Educator Effectiveness



▶ Recommendations

1. Allow for greater flexibility in educator evaluations by revising the OARs, specifically around the use of state assessments for evaluations, the Oregon Matrix, and other potential alternative rating tools
2. Embed and leverage the strategies outlined in the Equitable Access to Excellent Educators Plan into Oregon's ESSA State Plan

Accountability



▶ Recommendations

1. Develop a multiple measures dashboard for reporting that includes a broad set of indicators in order to create a more complete view of schools
2. Encourage a system of continuous growth by not providing schools with an overall rating
3. Add indicators to the accountability system that help provide a more comprehensive look at schools that address
 - Equity
 - College and career readiness
 - School climate



School Improvement

▶ Recommendations

1. Identify districts (instead of individual schools) when schools are in need of Comprehensive or Targeted supports
2. Enhance district and school-level collaboration and improvement planning by including external stakeholders in the diagnostic systems review and ongoing support
3. Adjust state-level supports and ability to exit status based on a review of school-level data and demonstrated improvement over time
