<p>Title I-C provides supplemental funding to establish and support educational programs for migratory students (MEP). The goal is to ensure that migrant children fully benefit from the same free public education provided to other children, including:</p> <ol style="list-style-type: none"> 1. To support educational programs for migrant children to reduce disruption 2. To ensure consistency in curriculum and academic standards across states 3. To provide coordinated and efficient educational services for migrant children 4. To offer opportunities for migrant children to meet challenging academic standards 5. To help migrant children overcome barriers to education and prepare for postsecondary education or employment 6.
