Hello State Summer Learning Grantees!

Please see below for **three key updates and next steps** regarding the State Summer Learning Grant.

1) Final Grant Awards

The finalized Grant Awards are attached to this email and will be posted to our [webpage](#) shortly.

Important Notes:

- All grantees listed in the final Grant Awards are approved to move forward with planning programs and incurring grant expenditures. Grant funds may be used to cover eligible expenditures incurred between **April 23rd** and **October 17th, 2025**.
- If you believe **you will not be able to spend your entire grant award** as listed in the attached, please let us know **as soon as possible** so that we may reallocate any unused funds.
- We are working on sending out grant agreements and loading funds in EGMS as quickly as possible. Our goal is for grant agreements to be sent out within the next 2-3 weeks. ***Please note your completed and finalized application must be submitted prior to being able to claim funds.***

2) Application Form Templates and Deadline Extension

Also attached to this email are the **required Supplemental Application Forms** for submitting your **Academic Goals** and **Program Schedules**. These will also be available on our [webpage](#) shortly.

Important Notes:

- To accommodate the unexpected delay in releasing these documents, the **deadline for submitting finalized Applications has been extended to Monday, June 23rd by 11:59 pm.**
- **To meet the final Application deadline of June 23rd ALL of the following Application components must be finalized and submitted:**
 - **Application Form;**
 - **Existing Plan** for Summer Programming documentation;
 - **Letter of Support** from one partnering entity (including the amount budgeted for their services);
 - **Academic Goals** supplemental application form; and
 - **Program Schedules** supplemental application form.
