<p>The purpose of Title I, Part D, Subpart 2 is to support the operation of local educational agency (LEA) programs that involve collaboration with locally operated correctional facilities:</p> <ol style="list-style-type: none"> 1. To carry out high-quality education programs to prepare students for secondary school completion, training, employment, or further education 2. To provide activities to facilitate the transition of such students from the correctional program to further education or employment 3.
