Dropout Prevention Activity #2	Academic counselor/advisor meets with each student to advise and plan for course scheduling around career interests, academic needs, and graduation requirements, working closely with students who are on the graduation watch list and monitoring white, female students who historically have had lower graduation outcomes. Students will use CIS or a similar program in advisory to assist with career and college planning.

Dropout Prevention Activity #3	Mental health counseling support is assigned to each high school for students struggling to maintain enrollment; academic progress; and/or social emotional support. This will help provided the emotional and mental health supports to increase student engagement and success in a variety of environments.

Dropout Prevention Activity #4	Morrow Education Center teacher - works directly with students at highest risk of dropping out due to attendance, credit deficiency, behaviors. Teacher will work closely with students, parents, and building administration to develop an education plan that will allow the student to earn either a diploma.

Dropout Prevention Activity #5	Family and student engagement by providing as many different learning opportunities as possible. We offer programs that range from Early College, CTE focused, to GED/credit completion, and online learning. We have focused our efforts in detailed tracking of students to ensure that we are supporting them in the best manner possible. Part of the engagement with families is making sure that they feel welcome in any building that they enter and that they are aware of all the options that we can offer their students. We also work with families that we know may be moving to keep them until a grading period is done so that their student will be able to transfer credits.
