

Oregon Coordinated Transition Services

Purpose: This resource aims to provide a high-level summary to assist individuals and families in learning about and connecting to transition services for which they may qualify to receive as they prepare for and enter life beyond high school. It also serves as a tool for disability support resources and agencies to foster connections with transition services, assisting individuals with disabilities achieve and maintain employment, further pursue further education or training, and other postsecondary goals. Please note that it is not intended to include all transition resources, many of which are available through local counties.

Vocational Rehabilitation Pre-Employment Transition Services (Pre-ETS)

Who may receive these services?

Students enrolled in recognized educational programs, ages 14-21 and have a documented disability are likely qualified to receive some Pre-ETS.

What do the services include?

Pre-employment transition services (Pre-ETS) include activities on self-advocacy, work readiness, job exploration, work-based learning, and counseling on post-secondary training.

For comprehensive Vocational Rehabilitation services, individuals must apply and be found eligible for VR services.

Students with an Individualized Education Program (IEP) will have transition services as part of their plan by age 16. Special Education services are available to eligible students from pre-kindergarten until the end of school year during which they turn 21 years of age.

An IEP transition plan must include:

- Postsecondary goals based upon age-appropriate transition assessments;
- Individualized transition services, including courses of study, to assist the student in reaching their goals; and
- Coordinated services with adult agencies.

Students 14 and older who are legally blind, or have a condition that will lead to blindness, can receive support to help ensure a successful transition from high school to college or the workforce.

- Job exploration counseling
- Work-based learning, which may include in-school, after-school, or integrated experiences outside the school setting.
- Counseling on enrollment in higher education transition programs
- Workplace readiness training to develop social skills and independent living
- Instruction in self-advocacy, which may include peer mentoring

How do the services help individuals get or maintain employment, post-secondary education and training?

Vocational Rehabilitation Pre-Employment Transition Services (Pre-ETS)

Pre-ETS are the earliest form of services available from Vocational Rehabilitation and are customized to the individual and community. Pre-ETS support students in exploring and refining their employment goal, and to gaining skills necessary for first steps in employment.

Special education services can help students prepare for life after high school through an IEP that includes goals and instruction focused on employment, further education, training, and, when needed, independent living. These transition services begin by age 16 and are designed to build skills for successful post school outcomes.
