

**Early Intervention/
Early Childhood Special
Education (EI/ECSE)
Services in Oregon**

Do you have concerns about how your child sees, hears, speaks, moves, plays, learns, or responds to others?



Who should I call?

Call the EI/ECSE referral and evaluation agency in your area. The phone number for your local agency is on the back of this brochure.

What happens after I call?

With the family's permission, the child may be screened and evaluated. This will help determine if the child is eligible for EI/ECSE services.

If the child is eligible, an Individual Family Service Plan (IFSP) is developed. The IFSP addresses the child's individual learning needs. A team of professionals works with the family to develop the IFSP.



What services does EI/ECSE provide?

EI/ECSE specialists work with children and their families to plan the services and supports they need. These may include:

- Special instruction and other services, including speech, physical, and occupational therapy.
- Home visiting to help families support their child's development in everyday activities.
- Itinerant services in community preschools.
- Connections to community services and programs.
