FARM TO CHILD NUTRITION PROGRAMS: INSIDE THE ISSUE

ODE Farm to School is now ODE Farm to Child Nutrition Programs!

In 2019, at the start of the last biennium, the ODE Farm to School Grant Program expanded to include Child and Adult Care Food Programs (CACFP) as eligible entities to receive Farm to School funding. It was decided that a Program name change and thoughtful rebranding was appropriate in order to highlight that Oregon-grown, raised, and produced foods reach several Child Nutrition Programs within ODE.

Officially introducing ODE Farm to CNP! To complement the Program name change, we have a beautiful new logo as well (see above)!

While examining the Program, it was also determined that to better reflect the intent of the Grant, moving forward the ODE Farm to CNP Procurement Grant will be retitled the ODE Farm to CNP Reimbursement Grant. In time, all Farm to CNP webpages, forms, and other documents and correspondence will be updated to reflect these changes.

FFVP Applications for SY 2021-2022 Now Open!

Applications for the USDA Fresh Fruit and Vegetable Program (FFVP) for SY 2021-2022 are now available on the **FFVP webpage**. These funds will cover any FFVP costs participating schools incur between October 1, 2021 and September 30, 2022.

If you currently have a school participating in SY 2020-2021 and is still over 50% free and reduced, no action is necessary for those particular schools as they will automatically be re-enrolled.

We will be accepting applications for SY 2021-2022 until **August 31, 2021**. Applications will be reviewed and turned around fairly quickly after this date. An application does not guarantee an award, as we will prioritize schools with the highest need.



FFVP Service Spotlight: Phoenix-Talent SD

We've received several questions about the types of items that can be included in FFVP service.

This month we are highlighting the FFVP purchases made by Phoenix-Talent SD at one of its FFVP schools for the month of May.



These included:

- Apples (Pink Lady, Opal, Fuji, Sugarbee)
- Grapes (Green and Red)
- Pears (Comice)
- Oranges (Valencia)
- Okra
- Grapefruit
- Apricots
- Baby Spinach
- Cucumbers
- Nectarines

This is an excellent example of a varied FFVP service that reflects the program goal of introducing kids to fruits and vegetables they may not see on their meal tray every day, as well as presents them with new varieties of some of the more familiar fruits and vegetables.

2021-2023 Biennium Awards: Reimbursement Grant Timeline

The 2021-2023 biennium started July 1, 2021. The Legislature has approved the Farm to CNP Grant again for this biennium. Therefore, all sponsors of NSLP, CACFP and SFSP programs (with a few exceptions) will automatically be opted in for the ODE Non-Competitive Reimbursement Grant for Oregon Grown & Processed Food, also known as the 'Reimbursement Grant.'

7/21/21 - Informal notification of awards. All programs that participate in NSLP, CACFP or SFSP (with some small exceptions) will be notified that they should expect an award amount.

TBD - Formal announcement from ODE Procurement, including new agreement. Grant goes live as soon as Sponsor returns Agreement, retroactive to July 1, 2021.

NOTE: Once a Sponsor exhausts their Reimbursement Grant funds they will be eligible to apply for additional funding through the Competitive Reimbursement Grant. Applications projected to open December 2021.
