TO: School Food Authorities (SFAs)

RE: SY 2024-25 Revenue from Nonprogram Food and Adult Meal Prices –

Action Required – Response Due: December 1, 2025

The U.S. Department of Agriculture (USDA) requires state agencies to ensure that revenues generated by a school food authority's (SFAs) sale of nonprogram foods complies with the requirements set forth in [7 CFR 210.14\(f\)](#). "Nonprogram foods" are foods and beverages, other than those sold as part of a reimbursable meal, purchased with funds from an SFAs nonprofit school food service account.

SFAs are required to determine if the percent of total revenue generated from nonprogram food sales is equal to, or greater than, the percent of total food costs that are attributable to the SFAs purchase of nonprogram foods. SFAs must ensure that nonprogram foods are priced sufficiently to meet the nonprogram foods requirement or must secure nonfederal funding to make up the shortfall in the nonprofit school food service account. Records must be retained to document compliance with Revenue from Nonprogram Foods requirements.

SFAs must notify the Oregon Department of Education Child Nutrition Programs (ODE CNP) of Revenue from Nonprogram Foods status by completing this web based [Revenue from Nonprogram Foods Reporting Form](#). In addition to collecting this information, compliance with Revenue from Nonprogram Food requirements is reviewed during the School Nutrition Program Administrative Review.

A couple of tools are available to assist SFAs with determining Revenue from Nonprogram Foods and with assessing compliance requirements:

- The [USDA Nonprogram Food Revenue Tool](#) helps SFAs calculate the amount of revenue required to meet requirements. To use the tool, the SFA must collect the cost of both program and nonprogram food, and the total revenue from the previous school year. Based on these amounts, the tool will calculate the minimum amount of revenue from nonprogram foods required to meet this requirement. The tool will also calculate the additional revenue, if any, needed to comply.
- The [ODE Revenue from Nonprogram Foods Calculation Worksheet](#) assists sponsors in calculating the proportion of program and nonprogram revenue and food costs. To use the tool, the sponsor must collect either the cost of both program and nonprogram food and nonprogram revenue and total revenue from the previous school year, or the cost

of nonprogram food and total food costs and nonprogram revenue and total revenue from the previous school year.

Per [FNS Memo SP 20-2016](#), Q&A #3, an exception from the Revenue from Nonprogram Foods requirement may be granted, per state agency review and determination, to SFAs that offer a “limited number of nonprogram foods with an identifiable per serving cost and are not able to accurately perform the assessment.” Adult meals do not have an identifiable per serving cost and are not eligible for this exception.

Per [FNS Instruction 782-5, Rev.1](#), *Pricing of Adult Meals in the National School Lunch and School Breakfast Programs (June 6, 1988)*, sponsors that sell adult meals must price those meals so revenues are, “sufficient to cover the overall cost of the lunch.”

All SFAs are required to certify one of the following pertaining to school year (SY) 24-25, using the [Revenue from Nonprogram Foods Reporting Form](#):

- Certify that Revenue from Nonprogram Foods is sufficient and is proportionally greater than or equal to Nonprogram Food Costs; **OR**
- Certify that Revenue from Nonprogram Foods is insufficient and is proportionally less than Nonprogram Food Costs; and indicate the plan to ensure that nonprogram foods are priced sufficiently to meet the nonprogram foods requirement or secure nonfederal funding to make up any shortfalls in the nonprofit school food service account; **OR**
- Certify that according to [FNS Memo SP 20-2016](#), “a limited number of nonprogram foods with an identifiable per serving cost are offered and are not able to accurately perform the assessment.” Only **a la carte milk** is sold and the revenue recovered is greater than or equal to the per-serving costs of the milk; **OR**
- Certify that:
 - Adult meals are the only nonprogram food,
 - Adult meals are priced or reimbursed according to [FNS Instruction 782-5, Rev.1](#), and
 - Any revenue recovered complies with [FNS Instruction 782-5, Rev.1](#); **OR**
- Certify that **a la carte milk and adult meals** are the only nonprogram foods. Revenue from a la carte milk, if sold, is greater than or equal to the per serving costs of the milk according to [FNS Memo SP 20-2016](#). Adult meals are priced or reimbursed according to [FNS Instruction 782-5, Rev.1](#) and any revenue recovered complies with [FNS Instruction 782-5, Rev.1](#); **OR**
- Certify that nonprogram foods are not sold and any nonprogram foods provided at no cost are recovered by nonfederal funds. *Note: This excludes adult meals provided at no cost.*

The [Revenue from Nonprogram Foods Reporting Form](#) must be completed no later than **December 1, 2025**.
