

The Value of Commodities Received Report shows schools the Value of the USDA Foods they have received during a certain time period. Business Managers often ask for this information at the end of the school year, and this is a report the Food Service Manager can run to provide that information.

Note: In WBSCM, it will have your values for both direct delivery and diversion/processing. It will not have values for USDA DoD Fresh or the USDA Unprocessed Fruit and Vegetable Pilot options. Those must be obtained elsewhere.



2. Fill in the dates under “Req. Delivery Date”. For school year 2022, it should be 07/01/2021 to 06/30/2022.
3. Click “Print PDF Output” to view a PDF or “Execute” to download in Excel format
