- Clarify conflict of interest and participation in grant reviews

- RFA Opens: June 7, 2021
- RFA Informational Webinar: June 11, 2021
- RFA Questions Due: June 22, 2021
- RFA Answers Returned (approximately): June 29, 2021
- RFA Closes. Applications Due: July 29, 2021
- Notification of Applications Received: August 5, 2021
- Notice of Intent to Award (estimated): August 27, 2021
- Estimated Grant Start Date: September 20, 2021
- Year 2 Grant amendments open: April 15, 2022
- Year 1 Grant End Date: June 30, 2022
