The Latino/a/x & Indigenous* Student Success Plan seeks to address historic and current systemic inequities in educational systems.

The plan centers equity and community by ensuring those closest to the problem help develop solutions.

Three components:

- Advisory Group
- Grants
- Informing educational practices statewide

^{*}Indigenous Mexican, Central, South American, and Caribbean

The Latino/a/x and Indigenous* Student Success Plan requires that we address the following:

- Educational disparities experienced by Latino/a/x and Indigenous* students
- 2. **Historical practices** leading to disproportionate outcomes
- 3. **Culturally appropriate best practices** from early childhood through post-secondary education

Values:

- Student Centered
- Policy and Systems Change
- Centering Cultural and Community Assets

Objectives:

- Improve reading & math kinder to 3rd grade
- Support culturally responsive pedagogy and practices
- Support culturally responsive curricula
- Support transitions to middle school and high school
- Address disproportionate discipline

Objectives:

- Increase engagement before and after school
- Increase early childhood education and kindergarten readiness
- Increase parental engagement
- Increase community colleges attendance
- Increase four-year post-secondary attendance

Approach:

- People Direct programs and services
- Practice Culturally responsive professional development
- Policy Supporting local policy recommendations



Funding Amounts & Grant Eligibility

Funding Amounts

Grant Amount and Duration:

- \$250,000 for the 2022-2023 school year
- \$50,000 used for startup costs, can be paid upfront
- Eligible for renewal at \$200,000 per year
 - (pending legislative approval)

Grant Eligibility

Who can apply:

- Community-based organization
- Early learning hub
- Early learning provider
- Schools or School district
- Post-secondary institution
- Educational Service District
- Tribes

Grant Eligibility

Projects must:

<u>Indigenous</u> students and youth populations and their families to <u>further the goals of the Plan</u> in their Application.




