- **Prescription Considerations:**
 - This 552-acre harvest will increase viability of the stand by reducing stocking levels to maintain proper stand density. The stand is currently overstocked and vulnerable to attack by a range of forest pathogens. Research has shown that fast-growing trees can resist bark beetle attack, some diseases, and mistletoe infection. Therefore, maintaining forest health means keeping individual trees growing well. This will maximize opportunity for future harvests and create a resilient stand suitable to the climate and ecology of eastern Oregon ponderosa and mixed pine stand types.
 - Thinning will be primarily from below, removing suppressed understory and co-dominant individuals. Overstory trees will be cut as needed to ensure continued stand growth. The stand will result with a multi aged and vigorously growing 60 sqft/acre basal area where forest health constraints allow.
- **Reforestation Considerations:**
 - The remaining stand will be grown forward with another entry anticipated in approximately 20 years.




