- **Prescription Considerations:**
  - Harvest in this area is intended to reduce stocking levels while retaining the uneven aged characteristics of the stand. Trees will be individually selected for removal across all age classes. Group selection cuts were incorporated into the previous harvest prescription in these stands and are not expected to be increased this entry.
- **Reforestation Considerations:**
  - Post-harvest the understocked areas will be planted with ponderosa pine and Douglas-fir if needed. The remaining stand will be grown forward with another entry anticipated in approximately 20 years.




