#### **Description of Project:**

Project work consists of the installation of culvert on a non-fish seasonal stream on the Cobmaster Trail. The culvert will be sized to meet state and federal standards and meet the 100-year peak flow requirement. The culvert location and approaches will be designed to ensure hydrologic disconnection from aquatic resources. This project requires in-water work and will adhere to the timing restrictions defined in the ODFW In-Water Work Period Guidelines. Trail construction will be completed by the REI OHV Trail Program staff using heavy equipment such as: mini-excavators and rock haulers.
