- **Leave Tree Considerations:** Foresters will work with Wildlife Biologist during sale layout. The following should be considered when determining final leave tree arrangements:
  - Stand Characteristics: Prioritize larger diameter and minor species trees within each unit as part of the retention strategy where operationally feasible.

- Seedlings: The unit will be planted with 100% Douglas-fir seedlings. Both plug and bareroot stock will be used. The majority of seedlings will be bareroot, with plugs used in rocky and slashy areas.
- Brush: A manual ground release will be completed following harvest operations to control competing vegetation.
- Leave Trees: Arrangement of leave trees will have no impact on reforestation operations.


