Good morning Peter

We are attaching a letter that was sent yesterday to Oregon's Joint Interim Committee on Carbon Removal. It is signed by 19 PhDs with vast experience in forest carbon accounting and life cycle assessment.

We believe that our letter will help address some of the misinformation that is being passed around Oregon (e.g. forests are #1 source of GHG emissions) and give support for Oregon's state inventory project that you are leading under the Forest Carbon Advisory Stakeholder Group. We would also like to open the door to offering guidance on any discussions of life cycle assessment of Oregon's forest sector.

Both Elaine and I will be at the Society of American Foresters conference next week and we'd be very happy to meet with you to discuss further. Edie will be leading a learning session on Harvested Wood Product carbon accounting, which will include an overview of different ways to account for HWP carbon (retrospective (e.g. historical/IPCC/EPA method) and forward-looking (e.g. 100-year method/CAR forest offset protocol/GHG Protocol). Elaine will be speaking to the methodological challenges of expanding attributional LCA to the landscape level. Bruce Lippke, President Emeritus of CORRIM, will be discussing history of CORRIM and how the integration across all phases of the product life cycle are needed to identify the best alternatives for implementing a carbon negative approach to wood utilization.

As a follow-up to my recent presentation at the Oregon Coastal Caucus Economic Summit, please find attached a letter directed towards yourselves as members of Oregon's Joint Interim Committee on Carbon Reduction. The letter and background information speaks to the complexities inherent in incorporating the forest sector into any carbon mitigation strategy. The letter has been co-signed by 19 internationally respected forest carbon specialists from across the country including several members of the science team that developed Managing Forests Because Carbon Matters, and past and current board members of CORRIM, a multi-institution research consortium that has been conducting scientific evaluations of the environmental performance of wood products and the forest sector since 1996. We believe the science and carbon accounting protocols we have summarized for your review will provide useful background for your upcoming decisions regarding carbon reduction strategies that would work in the Oregon context.
