Background

The Oregon Department of Forestry (ODF) is considering a potential Habitat Conservation Plan (HCP) and associated Incidental Take Permit for state forestlands west of the Cascade Range. ODF is currently underway with the HCP process, in collaboration with technical and policy guidance from other state and federal agencies. ODF is also seeking stakeholder engagement in this early phase of HCP consideration.

- Hear updates about the Western Oregon HCP's development and the status of conservation strategies, including:
 - A high-level overview of the methodology for habitat modelling and timber harvest modelling
