




- Administrative Draft HCP: Posted to ODF Website in March 2021
- Executive Summary: 13-page summary of HCP
- Summary of changes from October 2020 draft to March Administrative Draft on website
- The administrative draft is what is being assessed under NEPA

- ODF is currently completing an operational review of the administrative draft HCP
- A series of Q&A sessions with district staff about the HCP and an opportunity for review and feedback
- Making updates to HCP in response to district staff feedback through the Scoping Team
- Updates are generally focused on those needed to allow for ease of implementation, including monitoring
- Consistency in standards and management direction
- Clear definitions of covered activities and monitoring requirements



Examples of Changes Being Made

- Clarifying language in covered activities
 - Updating definition of landings
 - Updating definition of quarries and borrow sites
 - Moving standards or requirements from covered activities to conservation strategy
- Creating consistent definition of NSO dispersal habitat for compliance tracking purposes
- Clarifying the types of projects funded by conservation fund dollars


