Introduction to our survey

Greetings.

The Oregon Department of Forestry is conducting a poll to gain a better understanding of how current Forest Practices Act streamside protections for non-federal forestlands relate to goals for water quality, fish and wildlife, and forest health. To help inform Oregon's Board of Forestry on your unique perspective, we are asking you to join the conversation and participate in this poll. Your valuable input about these topics in the eastern Oregon or Siskiyou areas will help the Board better understand the issues and how best to prioritize them.

Recently, the Board asked the agency to start discussions about priorities for monitoring, in the form of science reviews or field data collection projects, relating to streamside protections in the Siskiyou and eastern Oregon areas. The Board will consider your input when assessing what work should be done to assess whether the streamside protection rules are working to achieve goals for fish and wildlife, water quality and forest health.

The agency routinely monitors outcomes for natural resources around forestry operations to determine whether the protection rules work. This monitoring is mandated by state law, rules and departmental policy. Science-based monitoring helps the Board know if rules are meeting goals and if changes are appropriate. For instance, after monitoring temperatures in some fish-bearing streams west of the Cascades, the Board chose to increase streamside buffers. On the other hand, after reviewing the most recent science around bald eagle recovery, those rules are being changed to decrease restrictions accordingly.

To help inform the Board about streamside monitoring needs in the eastern Oregon and Siskiyou areas, please join the conversation by taking this poll. There are seventeen (17) questions, and most should take less than a minute to answer. If we need more information, we may ask you to join one-on-one or group discussions. This survey is not a popular vote. Results will be used to convey to the Board the range of opinions regarding what streamside protections are important to review and why.

We greatly appreciate you taking time to help inform Oregon's forestry management discussion. Thank you in advance and we look forward to receiving your thoughts. 
