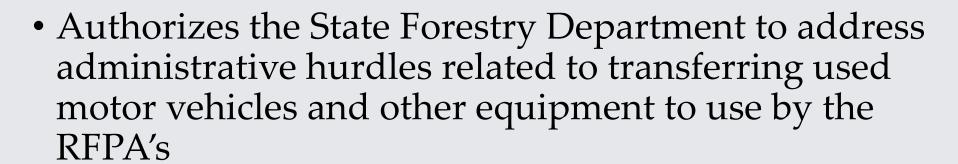

- **HB 2817**: Eliminates the closure of forestland, due to fire danger, by permit closure
- **HB 2819**: Authorizes people who enforce fire protection laws to issue citations if there are reasonable grounds to believe violations have occurred
- **HB 494**: DAS to study classification and compensation of forestry and wildland fire positions
 - Addressing wage and management compression, identifying deficiencies in ODF
- **SB 1051**: Transfers the authority to appoint a State Forester from the State Board of Forestry to the Governor





Creates a fund for RFPA use





SB 83: Hazard Map Repeal

- Removes the Wildfire Hazard Map from statute
- Removes the Map's mandatory regulatory structures that enforced building codes and defensible space standards in high hazard areas
- Maintains the building code and defensible space codes as "model codes" for the possibility of local adoption

HB 3940: Wildfire Funding

The goal of the wildfire funding workgroup (Fire 35) and HB 3940 was to achieve long-term, durable funding for wildfire mitigation and response in Oregon

- Mitigation Funding: 20% of the interest from the Rainy-Day Fund (estimated \$29 M biennium) and a new "Zyn tax" (estimated \$14 M biennium).
- Landowner Rates: Policy changes detachment of centralized administration costs from the local landowner assessments. HB 4133 (2024)

- Rural Fire Protection Districts: Allows RFPD's to receive revenues for services they have been providing
- Treasury Loans: Establish loan ability with the Treasury to seek timely payments





SB 5006: Christmas Tree Bill

\$195 Million dollars in one time biennium funding for ODF's fire and mitigation programs

- \$24 million SPA for severity including aviation costs
- \$7 million for mitigation funding
- \$9 million for immediate landowner rate offsets
- \$4 million for wildfire cameras
- \$150 million SPA for natural disaster response

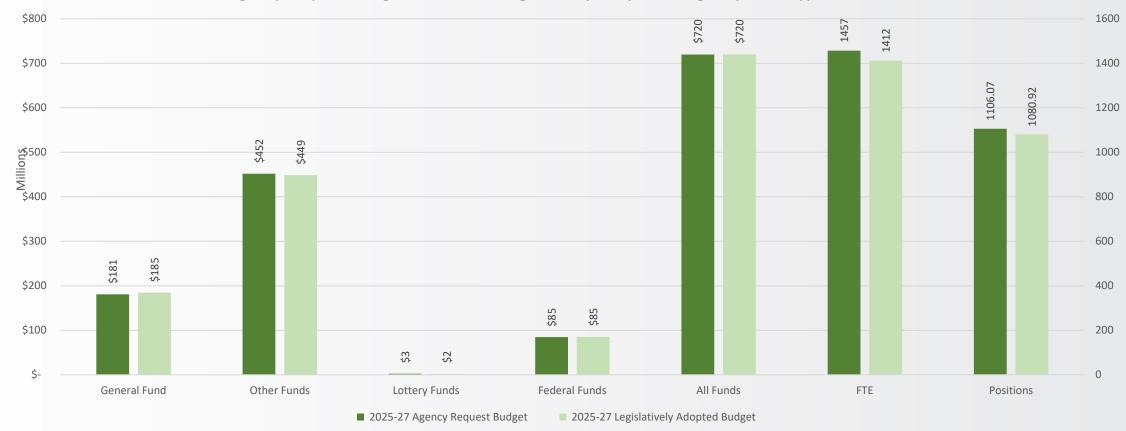
