What.Does.the.Compliance.Monitoring.Program.Do?

The purpose of the Compliance Monitoring Program (CMP) is to evaluate FPA rule compliance and identify areas that need improvement for training and education purposes. The CMP does these evaluations through scientifically-designed collection of information from forestry sites.

History.and.Background

Compliance Monitoring Program History

The Oregon Department of Forestry's Compliance Monitoring Program (CMP) was formally established in 2022 by Oregon Senate Bill 1501.

The purpose of the CMP is to evaluate Forest Practices Act (FPA) rule compliance and identify areas that need improvement for training and education purposes.

What is the FPA?

The Forest Practices Act (FPA) was first passed by the Oregon legislature in 1971.

The FPA was created to set standards for all commercial activities involving the establishment, management, and harvesting of trees on Oregon's non-federal forestlands.

Oregon law gives the Oregon Board of Forestry the responsibility to interpret the FPA and adopt rules for forest practices.

The Oregon Department of Forestry is responsible for administering and enforcing the FPA and the associated administrative rules.

CMP and HCP

The Habitat Conservation Plan (HCP) will describe the conservation measures in ODF's current Forest Practices rules that are intended to protect covered threatened and endangered species' habitat. These measures are intended to avoid, minimize, or mitigate potential impacts to the covered species that can result from forest management practices.

The data provided by the Monitoring Program will help ODF track HCP implementation.

Compliance.Monitoring.Program.Projects

2024 Reforestation Study

From October 2023 to May 2024, the Oregon Department of Forestry's Compliance Monitoring Unit studied reforestation following clearcuts on private timberlands, as required by Oregon's Forest Practices Act. The study estimated compliance with reforestation stocking density requirements by conducting field surveys to assess free to grow stocking density on a sample of harvest units and comparing these estimates to those required by the Forest Practices Act rules.

The study population was all clearcuts of at least two acres completed in 2016 and 2017 with private industrial and private nonindustrial landowners. A random sample of harvest units was drawn from the Forest Activity Electronic Notification database, screened for harvest completion along with other suitability criteria, and landowners were contacted for participation in the study.

Long-term Compliance Monitoring Study

The Board of Forestry provides the Compliance Monitoring Program priority rulesets that should be addressed for long-term study. As of 2024, the following rulesets were determined to be priority:

- Harvest near riparian areas
- Forest roads
- Steep slopes

The Program's next study focus is the Riparian Pilot Study.
