FOREST OPERATOR RECOGNITION PROGRAM

<u>PURPOSE</u>: This directive establishes guidelines for the Forest Practices Forest Operator Recognition Program.

OBJECTIVES:

- To publicly recognize operators that consistently exceed the Oregon Forest Practices Act and Forest Practice rules.
- To improve public understanding of the Forest Practices Act and its accomplishments.

AUTHORITY: ORS 527.630 It is the "...policy of the State of Oregon to encourage economically efficient forest practices that assure the continuous growing and harvesting of forest tree species and the maintenance of forestland for such purposes as the leading use on privately owned land, consistent with sound management of soil, air, water, fish and wildlife resources and scenic resources within visually sensitive corridors...."

SCOPE: This directive is to be applied statewide.

STANDARDS:

- Levels of Recognition (or categories).
 - Forest Operator of the Year. The Oregon State Board of Forestry will
 present three "Forest Practices Forest Operator of the Year" awards to
 operators selected by each of the three regional Forest Practice committees.
 Selected operators will be individuals/companies that consistently exceed
 the Forest Practices Act and Forest Practice rules.
 - Merit Awards. Merit award winners shall be selected from Forest Operator of the Year nominees. Winners must consistently exceed the Forest Practices Act and Forest Practice rules.
 - Letters of Commendation. Districts should give Letters of Commendation to operators that have shown concern for the environment during an operation, regardless of the degree of operation difficulty or past operator performance.

FOREST OPERATOR RECOGNITION PROGRAM

STANDARDS: (Cont.)

- B. Size of Operation to Recognize. Any size operation may be recognized.
- C. Type of Operation to Recognize. Either companies, contractors or individuals may be recognized. Awards are not limited to harvesting operations. Generally, landowners will not be considered for recognition as operators except in cases where the landowner is conducting the operation.
- Nomination Screening Criteria. Only operators who meet the following criteria will be considered for Operator of the Year or merit awards.
 - Consistency of the Operator. The operator can be counted upon to consistently do an outstanding job.
 - "Consistently" is defined as no violations of the Forest Practices Act within the last two years, and recognition by the Forest Practices forester of "exceeding rules" often. "Exceeds" is defined to mean that the operator prevents resource damage, and results go beyond the rules and the minimum required results.
 - Degree of Difficulty. The operator faced a difficult operation. (For example, most operators could do a good job on flat ground with no running streams involved.)
 - Innovation and Extra Effort. The operator used innovations, extra effort or other creative solutions in conducting operations while protecting or enhancing resources.
 - Results. The operator achieved resource protection results on the ground which exceed the intent of the rules, or otherwise enhanced protected resources as described in Board of Forestry policy.
 - Financial Risk. The operator assumed some financial risk in conducting the operation. (Money, time, or equipment, as opposed to the landowner paying the operator for cost plus profit.)

STANDARDS: (Cont.)

E. Weighing Factors. Operators who met all the nomination criteria will be considered for recognized Operator of the Year awards. The operator may have done an excellent job on one operation, but adequate at other times. In such cases, the operator should be considered for a Letter of Commendation or a Merit Award. The operator who consistently does an excellent job of exceeding the Act on several operations (either the same or different types of operations) should be considered for regional Forest Operator of the Year. An operator who does an excellent job on a few operations can still be nominated for regional Forest Operator of the Year, but more weight would go to the operator that does an excellent job on several operations.

F. Number of Awards.

- Forest Operator of the Year -- One award each for the Eastern Oregon, Southwest Oregon, and Northwest Oregon Forest Practices Regions.
- Merit Awards -- No more than one award per district except when the area director believes circumstances warrant otherwise.
- Letters of Commendation -- No limit.



General Description of Operation: Commercial Thinning/Selective Cutting on 1926.4 acres of Ponderosa Pine/Mixed Conifer forest on eastern slope of Cascades, northwest of Bend Oregon.

What were the protected resources involved and efforts involved:

- 1. Forest Land Base Selective thin to reduce basal area- risk is overcutting with no plan for artificial reforestation.
- 2. Riparian areas: Ponderosa pine is the dominant species in the harvest unit and in the RMA. There is a smaller but consistent component of White Fir as well as scattered pockets of Douglas-Fir, Engelmann spruce, and Quaking aspen. The understory is sparse and typically consists of pine seedlings, Green manzanita, or various grasses. The RMA was previously unmanaged in earlier timber harvests, and tree densities exceeded 400 stems/ac. through much of the RMA. Dwarf Mistletoe was pervasive in the Ponderosa pine component and many severely affected stems showed signs of die back.
 - a. Protections For the listed streams below the following efforts were made: Operations were restricted to periods when soils were dry or frozen; understory vegetation were retained in the inner zone, species in outer zone were specifically retained to promote hardwoods, aspen, and large healthy conifers were retained for regen to allow for multi aged structure and promote forest and riparian health.; Skid trails were minimized and waterbarred if slope was greater than 10%

- i. Three Creek (Medium Type F)
- ii. Snow Ditch Creek (Small Type N)
- iii. "Channels" with no flowing water. (RMA protections were left in place where the definition of a channel were not clearly defined (bed and bank, sorting of sediment, etc.)

Criteria of Award Nomination

Describe Operator's *Consistency* in performance over the years (use examples):

Although I have only inspected one Operation, according to the landowner – This operator and crew has been most consistent in delivering a good product by the end of operation for multiple years. For the portions of this 1926.4 acre operation that were inspected, overall consistency with slash management and adherence to silvicultural prescription were followed. They did not appear to be taking any shortcuts in terms of operating. Considering they have delivered on an operation for multiple years with no issues with ODF or with the Landowner, and completed a nearly 2000 acre thinning project, this operation exemplifies consistency of performance.

Describe the <u>Difficulty</u> and complexity of the operation nominated as well as past operations in regards to protection of forest resources:

Scale: Ensuring all staff show up each day for work, maintenance of equipment and keeping efficient with the rate of work on this large of a project is what makes this difficult in terms of a contract.

Trucking: This was a challenge because trucks (14 on the operation) were heading to Roseburg, Gilchrist, and a couple other small sawmills (Culver, Christmas Valley, Sisters). From the location of the operation, these were pretty considerable distances. 2 trips per day by truck to Gilchrist and only 1 trip per day to Roseburg.

Public Exposure: Many members of the public in Bend are concerned with the condition of the forests immediately to the west of Bend and the Forest Operations that go on there. The operator had a few run-ins with the public, which slowed progress, however the operator and crew members always conducted themselves in a professional manner. Considering numerous public run ins over the years of this operation, no complaints were made, which shows they were doing the right thing for the landscape and promoting social license to operate.

Topography/soils: Although much of the operational area is flat, there were a few steep pitches to be logged with ground based equipment. During the winter months where ground was not completely frozen, rutting would potentially be an issue. On those steeper slopes they were only operated on when soil impacts would be minimal due to dry or frozen conditions. However, during the frozen conditions, heavy accumulations of snow made operating economically unfeasible during those times

Sub-prescriptions: There were various prescriptions for basal area targets across the entirety of the operation. No marking guide was implemented, which made the call on which trees to cut on the operator. This demonstrates each person operating a feller buncher must have the experience necessary to see basal area across multiple stand types. Taking this much volume and not triggering obligation to reforest on this scale is a difficult task, especially with the various prescriptions for the operation.

Describe how the operator was <u>Innovative/Extra Efforts</u> (including matching equipment to the job) or used extra effort on this operation and then Past Operations:

Small scale mills – Due to some of the forced quotas (essentially caps on how many logs could go to Gilchrist) the landowner and operator had to get creative on where the logs that were cut could be milled. They found some small scale mill operators willing to take that wood. Dead fir (grand fir, killed by fir engraver beetle went exclusively to Dave Elpi's Mill (Operator of the Year 2021)

Multi-aged management: Silvicultural prescriptions were focused on multi aged management such that basal area by size class was more evenly distributed. This meant leaving perfectly good sawlogs on-site such that recruitment of seedlings and future entries would be more sustainable. In addition to that, there was no requirement to leave down wood due to the Harvest Type. The operator exceeded the forest practices act by leaving downed wood in appropriate areas to enhance biodiversity and soil health.

Aspen Restoration: Colonies of aspen present on the operation were restored by removing conifer, without any damage to these aspen stands, promoting habitat for ungulates and other terrestrial and aquatic species.

Soil Conditions: In areas prone to rutting or sedimentation, operations were conducted during frozen or dry soil conditions to minimize any disturbance. These efforts were especially important on areas of the operation that had some steeper slopes.

Describe **Results** in resource protection and forest management benefits:

Forest Health: The results of this operation positively effect forest health on the landscape because of the management of dwarf mistletoe by removing overstocked pine; removal of grand fir to manage population of fir engraver beetle; promoting aspen and hardwood species to provide for key wildlife habitat and general biodiversity; creating growing space for increased resilience against disturbance such as western pine beetle, mountain pine beetle, Douglas-fir beetle, and wildfire, all of which are present threats on this landscape

Fuels Management: From a fuels perspective, this pine and mixed conifer stand is being managed for stocking densities commensurate with historic range of variability prior to euro-American settlement. Instead of fire, logging and fuels management were the disturbers on this operation. Because the silvicultural prescription requires a combination of basal area, seedlings, poles and saplings to be arranged in a multi aged fashion, the over all fuel loading was reduced but with opportunity of adequate recruitment of different age classes of trees. Because of this stand structure and composition resulting from the operation, if this stand were to experience wildfire, it would be likely that: 1. The resistance to control the fire would be low and 2. The fire would likely have low to mixed severity in some areas to where live, mature overstory trees would likely be able to establish seedlings naturally due to their increased vigor and managed spatial distribute

Multi Aged Structure: Due to the multi-aged management: This stand will likely be ready for another entry in 15 years. Given the scale of the acres on the project, an ecologically appropriate amount of volume can be taken with relatively good economic feasibility. Because of the shortened entry interval, this operation and others alike will contribute to keeping the restoration economy of eastern Oregon afloat.

Describe the *Financial Risk assumed by the operator* as well as how much influence the landowner had on this operation:

The scale of this operation over 2 years was 1926.4 acres. Given that scale, operational efficiency is paramount because it is hard to gauge progress to the completion of the operation with the nature of forest operations. Equipment breaks, employees may not show up to work, weather can be adverse to hauling or operating. These obstacles can prove to create a risk for the operator in meeting the terms of the contract. Boulder Ridge decided to take the risk of taking on this large of an operation considering the size of their company and all other factors considered. To add to that, forced quotas on how much wood could be trucked to the nearest mill created a challenge in finding a home for the sawlogs to come off the operation. At one point, they were trucking logs over to Roseburg, which only allowed for one load a day per truck. With a total of 14 trucks on the operation, this put pressure on ensuring the loading of log trucks went seamlessly. Additionally, cutting logs on this scale made the use of a marking guide infeasible, which meant the operator had to eyeball which logs to cut to create multi aged structure without triggering any obligation to reforest, meaning that in addition to the length of the operation, the operator and rest of the crew had to show up and really pay attention to everything going on. This operation could have very easily put the operator in the red.

OTHER INFO that should be known for consideration to help form a solid picture of your nominee:

Every local stakeholder I have talked to about this operator has had nothing but good things to say about their professionalism and the quality, timely work they do. Boulder Ridge LLC exemplifies the idea of stewardship and is always willing to do the right thing for the landscape.



This exemption does not impact the applicability of the remainder of Oregon's cultural resource laws (ORS 97.740 – 97.994, 358.905 – 358.961, and 390.235 – 390.240). If human remains are encountered ORS 358.920 and ORS 97.745 require all excavation to stop and the find be reported to the landowner, the state police, the State Historic Preservation Officer and the Commission on Indian Services. ODF Staff cannot provide cultural resource advice or guidance, and landowners are encouraged to contact the State Historic Preservation Office here or at 503-986-0690.

Boulder Ridge LLC Reference Letter

I have worked with Boulder Ridge LLC in my capacity as Forester for Gilchrist Forest Products (GFP) since late 2021. During that time, we have worked together on several projects with different challenges and goals to be implemented. These included: fire salvage with resource protection, removal of multiple products, implementation of DxP cutting prescriptions, sometimes navigating a myriad of operating restrictions on Forest Service sales and logistical challenges associated with working many miles outside their normal working circle.

Matt Mahoney and his brother Tyler are well engaged with the different aspects of their operations and actively seek to expand their knowledge and understanding of Forest Service contracts and other aspects of their business. They also work well together and divide the workload of running different facets of the business between them. They seek to understand their contracts and do not neglect following up with post operation reviews to learn from any mistakes as well as successes so this learning can be applied to future projects.

We initially worked with Boulder Ridge on a BLM fire salvage sale in winter 2021 – 22. This project was in wildlife winter range and included archaeological sites to be protected within the harvest area. The BLM was hesitant to allow winter operations due to wildlife and resource protection concerns. Boulder was able to complete this salvage with minimal impact to these resources and provide an excellent example of good winter operations to educate BLM resource specialists. This continued in spring 2022 where they were able to complete another BLM salvage located 160 miles from the sawmill where time was of the essence to prevent product value loss from blue stain. This too was completed in a timely manner, providing the BLM with a quality job so the site could be readily replanted plus providing some good photos of salvaged yellow pine traveling across the high desert.

Boulder Ridge is also adapting to the new Forest Service business model of passing tree cutting decisions on to the logger and timber purchaser. They willingly took on this challenge with GFP in summer 2023 on a central Oregon timber sale and worked to develop their crew to work efficiently implementing DxP timber designation on this project. We also incorporated mechanical precommercial thinning into the logging operations on the project while working through a myriad of overlapping seasonal restrictions. The lessons learned in 2023 will be incorporated into their operations as we come back for another go-round on the Core DxP project in 2024. The time spent learning DxP has already provided dividends on subsequent timber sales harvested in winter/spring 2024 and where they are currently operating.

We have built a good working relationship with Boulder Ridge and look forward to continuing working with Matt and Tyler as they grow their company and capabilities.

Staton Forestry has completed two projects for the Oregon Department of Forestry's Gilchrist State Forest. Through both projects, Staton Forestry has produced work worthy of recognition. They are consistently on time, communicate well, give extremely competitive bids, and produce fuels treatments that both meet the prescription as well as are aesthetically pleasing to the communities in which they take place. Their work has greatly contributed to the security of the Crescent, Gilchrist, and Jack Pine communities through their fuels mitigation treatments, and members of the community consistently complement the work that they do, stating their appreciation for the extra security from wildfire but also for the care and consideration they put into their product.

Describe the <u>Difficulty</u> and complexity of the operation nominated as well as past operations in regards to protection of forest resources:

While most of the ground that Staton Forestry has treated has been relatively flat and straight forward, there are extra factors for consideration when working around private property, homes, and along agency boundaries. Operating times can become more limited when working around the public as the sound of equipment operating in the early mornings and evenings can be a disturbance. Staton Forestry worked hard to accommodate the people in the community and took that into their calculations for how long the project would take. When working along federal and state forest boundaries, they took extra precautions to observe the property lines and avoid issues by hanging extra flagging when necessary. Much of the ground that was treated consisted of overgrown lodgepole thickets which can be difficult to navigate and cleanly treat. They minimized damage to the residual stand and left the desired wildlife vegetation, such as larger downed logs and small pockets of forage. They also mulched large, decades old landing piles to the point that they were indistinguishable from the rest of the forest. They also had to operate through varying levels inclement weather, whether it be high fire danger or a few inches of snow. During fire season, Staton took great caution while operating, avoiding sources of ignition and performing thorough fire watches. During winter while most mastication projects come to a halt, Staton continued to work, utilizing snow removal techniques that allowed for significant progress on the project. No matter the difficulty, Staton Forestry maintained their timeliness and their high standards, and consistently left a clean, well-manicured fuels treatment.

Describe how the operator was <u>Innovative/Extra Efforts</u> (including matching equipment to the job) or used extra effort on this operation and then Past Operations:

Staton Forestry employs a multitude of equipment to ensure the end state of the project meets their standards. During their operations on the Gilchrist State Forest, they deployed boom-mounted masticators, skid steer masticators, and dedicated mulchers. The utilization of these various types of equipment is how they are able to create fuels treatments that are both effective and aesthetically pleasing to those in the community. They typically would use the boom-mounted masticator first to cut and break down the thickets of small diameter trees. The skid steer masticators then break down the larger chunks of trees and stobs left by the boom-mounted masticator. And finally, the dedicated mulcher passes over and completely obliterates the remaining wood debris. Oftentimes, mastication operations can leave large, broken woody debris or half-cut small diameter trees that can be not only hazardous but also unsightly. However, Staton Forestry's use of all these pieces of equipment leads to a clean, park-like project area.

Describe **Results** in resource protection and forest management benefits:

Since its purchase in 2010, the Gilchrist State Forest has been managed through chip sales. The forest is primarily comprised of young stands of lodgepole and ponderosa pine thickets; a condition from which occurred due to extreme overharvesting by previous ownership. Like other state forests, the management of the Gilchrist relies solely on the revenue created from timber receipts, and due to the slow chip market, much of the management of the forest has heavily relied on the securing of grants. These grants have allowed us to begin to properly treat areas that border private and federal ownership. The work that Staton Forestry has done greatly contributes to the security of not only the community from the forest, but also the forest from the community. One of the largest wildfires in recent history on the Gilchrist State Forest was caused on private land which then spread onto state property. With the fuel breaks Staton has been creating, the fire would have never reached the size it had become. These strategically placed fuels treatments are the most effective way for the state forest to protect our resources while also contributing to a healthier, more resilient forest.

Describe the <u>Financial Risk assumed by the operator</u> as well as how much influence the landowner had on this operation:

Staton Forestry has continued to win mastication contracts by submitting extremely competitive bids. Due to the fact that we must award the contract to the lowest bid, operators must balance their margins. If the bid is too low and the work takes longer than expected, or equipment malfunctions there is always a chance of loss. However, if the bid is not low enough, competing companies can be awarded the contract, causing you to lose out completely. Mastication work has been more competitive over the years. Influxes in funding for wildfire prevention have brought more operators into the bid pool. Staton Forestry has succeeded in not only being awarded contracts based on their bids, but they have also succeeded in standing out as a company that exceeds expectations. The state is the landowner of the Gilchrist State Forest, and the influence for these projects was through treatment prescriptions and basic contract administration.

OTHER INFO that should be known for consideration to help form a solid picture of your nominee:

Staton Forestry has gone above and beyond compared to what we typically see with mastication projects within the area. No matter the situation, they have continued to find a way to make sure that we as the land managers, as well as the public, are happy with the work. They understand that many of these people moved to rural areas to be able to enjoy the forest and all its benefits, therefore they manage it in a way that they too would appreciate if they were living there. Beyond their product, Staton Forestry has always maintained an excellent attitude and communication throughout. We are extremely grateful for their contributions to our forest management and hope to continue to work with them in the future.





Behind Homes in Jack Pine Village 1







NOAP Changes: The notifier must inform the Oregon Department of Forestry of any changes in a NOAP before the activity takes place. A new NOAP may be required.

Protection of Cultural Resources: Under ORS 358.920 a person may not excavate, injure, destroy or alter an archaeological site or object or remove an archaeological object located on public or private lands in Oregon unless that activity is authorized by a permit issued under ORS 390.235. ORS 390.235 (5) exempts forestry operations on private lands from the permit requirement unless the site contains human remains, funerary objects and objects of cultural patrimony, or objects associated with a prehistoric Indian tribal culture. This exemption does not impact the applicability of the remainder of Oregon's cultural resource laws (ORS 97.740 – 97.994, 358.905 – 358.961, and 390.235 – 390.240). If human remains are encountered ORS 358.920 and ORS 97.745 require all excavation to stop and the find be reported to the landowner, the state police, the State Historic Preservation Officer and the Commission on Indian Services. ODF Staff cannot provide cultural resource advice or guidance, and landowners are encouraged to contact the State Historic Preservation Office here or at 503-986-0690.




