2025 AMENDMENTS:

- 1. Edited Headers and Footers for all IRA Parts A, B, C; to align with 2022-2025 Agreement period.
- 2. Added Local Resources definition (Part A, All Resources, page 3 of 14) and added clarifying language regarding required daily commuting of Local Resources (Part A, All Resources, page 9 of 14).
- 3. Removed 'demobilization (Check out time)' from list of items that are compensable within the Daily Rates section to provide consistency with current and past practices (Part B, Water Handling/Heavy Equipment, page E1 of E4).
- 6. Added full compensation language, including Daily Rate and Extended Shift language to the following:
 - Part B, Faller, page FAL1 of FAL2
 - Part B, Vehicle w/Driver, ATV, page VEH1 of VEH2
 - Part B, Radio Operator, page RADO1 of RADO2
 - Part B, Security Services, page SEC1 of SEC3
- 7. Added full compensation section, including Daily Rate, Extended Shift, and Double Shift language for Emergency Medical Services (Part B, Emergency Medical Services, page EMS1 of EMS7).
- 8. Added requirement that Resource Providers must provide Light REMS Option for each Standard REMS Option provided. Standard and Light REMS must each have a separate Daily Rate (Part B, Emergency Medical Services, page EMS5 of EMS7)
- 9. Added Option 13: Camp Medical Team without MEDL, to Emergency Medical Services Resource Information & Rate Sheet (Part B, Emergency Medical Services, page EMS6 of EMS7)
