Director message



Over the past few weeks, I have had the honor of traveling parts of the world within Oregon, meeting leaders from Ukrainian, Tongan, Latino, and other communities, and visiting organizations that welcome and support immigrants and refugees every day. I was even invited to watch a youth soccer game- *el juego bonito*, “the beautiful game”, which truly brings together people together from all cultures. These moments have been a reminder of the strength, resilience, courage, and hope that live in our communities, even during difficult times.

We are also closely watching federal H.R. 1 and what it may mean for the people we serve. According to the [state’s analysis](#), this bill could bring deep cuts to programs like Oregon Health Plan (Medicaid), SNAP (food benefits), and education. These aren’t just numbers, they are doctor visits for a parent, meals for children, and opportunities for students to succeed.

The bill also raises [certain legal fees](#) tied to court and immigration processes, making it even harder for low-income individuals and families to get legal help as they navigate complex immigration processes. These losses and added costs would be felt in real and personal ways.

Our strategic planning process is still underway, and the voices I have heard over these past weeks will shape that work. I am deeply grateful for the trust shared, the stories told, and the partnerships growing stronger every day. In the weeks ahead, we will continue listening, learning, and building together. The challenges

in front of us are real, but so is the strength of our communities. With Governor Kotek's [reaffirmed commitment to immigrant and refugee communities](#), we know that Oregon's values of dignity, safety, and belonging will remain strong as we work to ensure every person has the opportunity to belong, contribute, and thrive.

What can employers do to prepare?

We'll be hosting sessions on August 26th and October 1st to cover the intersections of civil rights law and heightened federal immigration action so that you can stay compliant and understand your obligations.

Make sure you have the information you need on:

- Oregon as a sanctuary state and what this means for your business
- Steering clear of national origin discrimination complaints and hiring pitfalls
- Preparing for a potential I-9 audit, including mandatory notification of employees
- What to do during and after an ICE audit or raid
