

Service group scoring

Service groups organize people with similar ages and support needs together. There are fourteen service groups, with a maximum of five groups within each age range.

Support needs range from very low to very high. Individuals who have very high support needs may need this support for a variety of reasons, therefore, individuals may be assigned to the "Very High" group due to having very high general support needs, very high behavioral support needs, or very high medical support needs.

To create the service groups, questions and possible responses to the Oregon Needs Assessment (ONA) are grouped into seven categories. Those categories are:

- General support need (GSN) score
- Medical support need (MSN) score
- Support person performs score (this means the support person performs the task for the person with I/DD)
- Behavior support need (BSN) score
- Behavior intervention/management frequency score
- Positive behavior support plan (PBSP) score
- Emergency/crisis services score

The answers within each category are added together to create a score.

The chart below shows the 14 service groups and the scores assigned to each. Descriptions of the seven categories follow this chart.

General support need (GSN) score

Below are the items from the ONA that are used to generate the GSN score.

- Coding options range from 1 (independent) to 6 (dependent).
- The final three columns are codes for non-responses or responses that are not on the scale from independent to dependent. To ensure consistency, all items must have a response.
- The responses are added together to become the GSN score.

- There are eight possible responses to each question. Those responses are given one of three codes: 0 (does not receive), 1 (receives less than weekly), 2 (receives weekly or more but not daily), or 3 (receives daily or more).
- The responses are added together to become the MSN score.

Support person performs score

- For each item in the medical support needs section, the ONA also asks whether a support person performs the treatment, monitoring or therapy.
- If the person receives treatment, monitoring or therapy at least daily and a support person performs that task, then the question is coded is a 1.
- The responses are added together to become the support person performs score.

Behavior intervention/management frequency score

Below are the items from the ONA that are used to generate the behavior intervention/management frequency score.

- Proactive strategies and physical prompts item: A response of daily or more is coded as 1 and a response of less frequently than daily is coded as 0.
- Safeguarding interventions item (also known as PPIs): A response of monthly or more is coded as 1 and a response of less frequently than monthly is coded as 0.
- The responses are added together to become the behavior intervention/management frequency score.
