- The restaurant kitchen analogy of Data Governance
   Leela Richman: (comparing data governance) to something we can relate to: a restaurant kitchen.
   Think of data like the ingredients that go into making a meal. There is usually a Head Chef that
   oversees other kitchen staff as they combine ingredients, use kitchen equipment and put together
   a meal. We expect them to follow certain health and safety protocols to avoid mishaps like food
   poisoning.

In a good kitchen, we know where the ingredients come from, how to combine them, what tools to use and how and who is doing what. We have ingredients, tools and people working together. Recipes, protocols and clear division of tasks keep the kitchen running smoothly.


Data governance works the same way. It sets out structure, standards and accountability for overseeing data assets.


