

Problem Statement & Theory of Change (a hypothesis that connects the steps to the goal) Problems We are Trying to Solve:

ODHS needs to continue to staff and document the need for using supervision levels.

ODHS also needs to increase support to and the quality of family time ODHS needs to increase support to and the quality of family time.

Initial family time is not occurring most of the time until more than five days after children's placement in substitute care.

Problem Statement: In District 11, prompt, frequent, and quality family time between parents, siblings and children in substitute care is not always occurring and/or is not always appropriately documented.

Proposed Theory of Change:

By focusing on improving the process to refer children and families to their initial family time, D11 will be more likely to assure children and families receive initial family time within 48 hours and subsequently D11 will improve Placement Stability, Permanency within 12 months (usually reunification), 13-23 months (usually reunification or guardianship) and 24+ months (usually adoption).

By focusing on improving the quality and frequency of family time, D11 will improve Placement Stability, Permanency within 12 months, 13-23 months and permanency in 24+ months.

PLAN What tasks will we take to attempt change? How will it impact the measurement? Who is responsible for the task? What resources are needed? How and when will this be communicated to staff?

Measurements

What are we going to measure?

Whether Time to initial Family Time (1027-D) decreases; CFSR Data on Visitation between Children, Siblings and Parents, Item 8 the strength rating will increase; whether a discussion occurred with regard to a large co-resource parent/biological family event occurred; and case note searches monthly to determine if informal discussions on supervision levels and family time are being documented.

How will we know the plan is working?

Time to initial family time will decrease and more children and birth parents will have their initial family time within the 48-hour timeframe. CFSR data on visitation between parents and children will increase its strength finding from its current level (38%). Placement stability will increase.

How will we determine all families are being impacted equitably? The data that is pulled monthly could be disaggregated by race to determine if families of color are waiting longer for visits than white families and we could evaluate the CFSR (qualitative data) as well.

Advisory Committee Review and Recommendations

Review/Recommendation (include date of review/recommendation): 12/27/2023

- 1. Look at and review with the site, trends from the last few years from the CFSR reviews which went from 83% down to the percentage where the site selected it at to see if there were any trends which could be informative for the site in action planning
- 2. Note barriers in visits not taking place when Katrina reviews the case notes to share with the site so new action items can be planned around addressing those barriers in their action plan.
