Adoption Savings for Placement Stability- Eligibility

Provide services to promote family functioning and placement stability to eligible families, children/young adults. Eligible families, children/young adults hereinafter referred to as "Client or Participant", includes the following:

- Families residing in Oregon whose adoption of children through ODHS or another public child welfare agency or private adoption has been designated or finalized;
- Children/young adults residing in Oregon whose adoption was through ODHS or another public child welfare agency or private adoption has been designated or finalized;
- Families residing in Oregon whose guardianship of children through ODHS or another public child welfare agency or probate process has been approved to proceed or has been established;
- 4) Children/young adults residing in Oregon whose guardianship through ODHS or another public child welfare agency or probate process has been approved to proceed or established;
- 5) Families residing outside of Oregon whose adoption of a child from Oregon ODHS custody has been designated or finalized; and
- Children/young adults residing outside of Oregon whose adoption from ODHS has been designated or finalized; and
- 7) Families residing outside of Oregon whose guardianship of a child from Oregon ODHS custody or through a probate process has been approved to proceed or has been established; and
- 8) Children/young adults residing outside of Oregon whose guardianship from Oregon ODHS custody or through a probate process has been approved to proceed or has been established.

Definitions

"Post Adoptive Family" means a family whose adoption of a child or children through ODHS has been designated or finalized, or a family who resides in Oregon whose adoption of a child or children through another public child welfare or private agency has been designated or finalized. "Post Adoptive Child/Young Adult" means a children or young adult ages 0-21 years old whose adoption through ODHS has been designated or finalized, or a child/young adult ages 0-21 years old who resides in Oregon whose adoption through another public child welfare or private agency has been designated or finalized.

"Post Guardianship Family" means a family whose guardianship of a child or children through ODHS or a family that resides in Oregon whose guardianship through another public child welfare agency has been established or approved to proceed.

"Post Guardianship Child/Young Adult" means a child/young adult whose guardianship through ODHS or who resides in Oregon whose guardianship through another public child welfare agency has been established or approved to proceed.

"Post Permanency Family" means a family whose guardianship or adoption of a child or children through ODHS has been designated or finalized, or resides in Oregon whose adoption or guardianship through another public child welfare or private agency has been designated or finalized.

"Post Permanency Child/Young Adult" means a child/young adult whose guardianship or adoption through ODHS has been designated or finalized, or resides in Oregon whose adoption or guardianship through another public child welfare or private agency has been designated or finalized.

Confirmation of eligibility status:

Prior to expenditures being coded to post adoption/post guardianship for TL and TL Prevention, the Resource Management team will confirm this section has been filled out and that they are showing as having been in an adoption or guardianship.
