# **Statewide**

Vision:

Oregon has an abundance of safe, diverse, and affirming resource families, that reflect the diversity of children, youth and young adults in foster care and are supported and equipped to meet their unique needs within their communities.

Throughout April districts and champions focused on building meaningful supports for resource families and youth experiencing foster care. We continue to see the strides being made in these areas which all contribute to enhanced retention of resource families. These varied supports, informed by the voices of resource families, build and create a ripple effect which enhances connection, longevity and ultimately results in better placement stability and outcomes for youth.

Several districts continued with their Dinner and Discussion events which feature different topics relevant to resource families. Districts provide meals, enrichment and childcare and a safe and open space for dialogue. In D9, 10 and 15 they focused on discussing out of home care assessments, bringing in a panel of child welfare experts to answer questions from families. In D12 they followed a similar theme covering ODHS policy and procedure. We are hearing great feedback from families who appreciate the opportunity to engage in conversation and find connection with fellow resource families.


Through fostering connection and collaboration with community partners, two districts are launching enhanced mental health supports for resource families and children experiencing foster care. D7 secured a Systems of Care grant to fund a grief and loss support group for resource parents. The grant, written in partnership with the Waterfall Clinic, will provide a monthly space where resource families can process the grief and loss associated with fostering while building connections with other families experiencing similar situations. D1 is in the beginning phases of a pilot project to match specific therapists for children, youth and their families impacted by foster care, as well as for resource parents. The project will provide more timely care to youth and add vital resources to support their mental health. We are looking forward to the development of both projects and to seeing the positive outcomes associated to them.


Much occurred behind the scenes this month in preparation for May- National Foster Care Month. While we aim to support and celebrate resource families throughout the year, May is always a bustling month of activity. From family fun events to flower deliveries, there is something happening in every corner of the state. We are so excited to appreciate families and spread awareness about foster care.


Also occurring this month was another Fostering Pride event. The virtual events produced in collaboration with Basic Rights Oregon and Unicorn Solutions provide a tailored experience for LGBTQIA2S+ individuals and families and/or those seeking to support LGBTQIA2S+ youth. The events include presentations and a panel from those with lived experience as well as 1:1 connection with local retention and recruitment champions.


This month, in total, we received 111 inquiries including 73 inquiries for general foster care, 29 for certified respite, and 9 related to general adoption.

# **District 1**

This month there was a focus in D1 on recruitment and preparing for Foster Care month. Partnering with a child welfare employee, recruitment materials will be distributed within the local community to those that have the skills and are equipped to be certified for teens as well as certified respite providers. **These are recruitment goals #1 and #4.** Another connection was made with Astoria Pride and the Lower Columbia Q Center to partner in the recruitment of LGBTQIA2S+ allied families, recruitment **goal #2.** 


A community action team meeting was held this month where recruitment flyers were distributed. The juvenile probation team, youth and family support specialists with the local mental health organization, youth wraparound coordinators and workers from the Columbia Pacific CCO all received recruitment flyers. The need for LGBTQIA2S+ homes (recruitment goal #2), homes for teens (recruitment goal #1) and certified respite (recruitment goal #4) was the focus.


The D1 champion met with GOBHI to finalize plans for a community recruitment event. The event is scheduled for May 29<sup>th</sup> and DD Services, Every Child, ODHS Volunteer Drivers and CASA have been invited. Our goal is to have several programs and organizations available to talk with the community about the many opportunities to help children youth and families impacted by foster care.


This month the beginning stages of a proposal for a pilot project in Columbia County began. This proposal will look to contract with the local mental health agency to have specific therapists available for children, youth and their families impacted by foster care, as well as for resource parents. This project will align with a new retention goal (goal #5), which would improve wait times for children and youth in care as well as give stability to the mental health needs of children and families impacted by foster care.



This month two general applicant families received their application packets. They are both nearly done with RAFT and will be working on the application as their next step in the certification process.


The district had 19 inquiries this month. There were 5 inquiries for respite care, 12 inquiries for foster care and 2 adoption inquiries.







Retention and recruitment efforts continue in District 3. Collaboration with community partners, ODHS staff, and Every Child continue to impact our resource families in positive ways.



Linn, Benton, Lincoln

#### Vision:

Oregon has an abundance of safe, diverse, and affirming resource families, that reflect the diversity of children, youth and young adults in foster care and are supported and equipped to meet their unique needs within their communities.

Our district participated in a statewide virtual Fostering Pride event on April 16th, drawing interest from families across the state and resulting in three new inquiries specifically for our district. Overall, April saw 15 new inquiries for District 4, including nine for general foster care, five for respite care, and one for adoption. Notably, several inquiries aligned with our targeted recruitment demographics, including 4 homes for recruitment goal 1 (expanding resource homes with experience and/or training to support LGBTQIA2S+ children and youth) and 1 home for recruitment goal 6 (culturally specific homes).


Our Facebook page, *Linn/Benton Foster or Adopt*, which boasts 631 followers, is undergoing a makeover. The champion team met with Lindsey Kort, the ODHS Digital Media Manager, to discuss strategies and recommendations. Lindsey unified our foster care and resource family Facebook pages statewide, simplifying information access, increasing relevant content, and improving post monitoring.


Much of April was dedicated to planning May's resource parent appreciation activities. We've raised \$2000 towards our \$5000 goal for the *Flowers for Fosters* program, which aims to deliver hanging flower baskets to every resource home in our district. We aim to bridge the funding gap before our May 15th deadline.


Additional May appreciation activities include a foster care awareness carwash in Lincoln County, an "unboxing" fun day providing high-end shoes to kids in foster care through the *Heart to Soles* program, Papa Murphy's pizza distribution, and a family fun day in the park for Linn/Benton resource families.


A Lincoln County church congregation, *Atonement Lutheran*, has taken it upon themselves to support resource parents. They have taken a specific interest in promoting reading. Beginning in June, they will assemble a book club gift box each month for two Lincoln resource families over the next year, containing age-appropriate books and a \$50 Papa Murphy's Pizza gift card.

This month, we launched our new resource parent exit survey with Power Bi integration, enabling us to better visualize and report data to district leadership. We've already received four exit surveys, which will guide the development of **retention goal 3:** a guiding document.

During the month of April there was a variety of work focusing on action items as a part of the Lane County retention and recruitment goals.

In April the D5 champion participated in the Youth and Children Behavioral Summit Event. While tabling at this event several new connections were made with professionals in the community who are wanting to help support local resource parents. (Recruitment Goal #1: Increase the diversity of resource homes)

New yard signs were distributed throughout the community during this month. The D5 champion placed 25 yard signs in various neighborhoods in the Lane County area. (Recruitment Goal #3: Increase general recruitment advertising efforts)

D5 certification staff attended a community event at the Eugene Roller Derby as a recruitment effort. (Recruitment Goal #1: Increase the diversity of resource homes)


On April 22 Lane County Every Child held an evening support gathering for resource parents. This was well attended with 20 resource parents and 2 respite providers attending. A meal was provided and there was time for resource parents to connect socially. (Retention Goal #1: Build 3 new direct support networks for resource families)


In April, we held a productive D5 quarterly retention and recruitment meeting, attended by the D5 champion, D5 district manager, program managers, and certification supervisors. We discussed two key focus areas: improving inquiry responses and certification assignment processes, and brainstorming district practice goals to enhance retention efforts for resource parents. (Recruitment Goal #6: Increase communication about recruitment effort and data to D5 staff and management)


The D5 champion worked with the statewide champion workgroup on the development of customer service training. Specific work was done on a module focusing on engaging and communicating with resource parents. The D5 champion conducted interviews with resource parents to assist in the development of this training. (Retention goal #2: 85% of staff will complete and apply customer service training)


Ongoing planning was developed for May's resource parent appreciation events. This included planning for the Building Bridges Conference. New community donations were received as a part of the preparation. These donations will be given out as thank you's at the conference for resource parents. Two workgroup meetings were held with ODHS staff and the D5 Champion continuing ongoing work for this event. (Retention goal #3: Increase resource parent participation by 40% at regular training events)

D5 received 8 new inquiries in the month of April. These consisted of 5 respite care inquiries and 2 general resource home inquiries and 1 adoption inquiry. (Recruitment goal #5: Increase number of inquiries to new opened homes from 35% to 50%).






April was a busy month filled with resource parent appreciation event planning, supporting new inquiries, and planning for future resource parent support groups. The D6 certification team spent the month finalizing plans for our resource parent appreciation event in May. We are doing a western-themed BBQ at the Wildlife Safari, and we will have gift baskets for each resource parent in attendance. We have received generous donations from our community and have partnered with other organizations in Douglas County to show an even greater appreciation for our resource parents this year. This month we also created certificates of appreciation for every certified family that includes their certification date and how long they have been certified. These certificates are signed by our program manager and district manager and will be given to our families in May.


This month we met with the Independent Living Program (ILP) to discuss bringing an ILP support group for teenagers aged 14 and older to occur on the same night as our resource parent support group. We aim to increase the attendance of resource parents at our monthly support group, allowing them to take a break while also ensuring that the teens in their care benefit from participating in the group sessions (**ongoing retention goal #1 increase monthly attendance to support group**). This teen group will focus on teaching youth necessary skills to prepare them for living independently. The first group is anticipated to start in June. In the meantime, D6 Champion, Myressa Starnes, will be contacting every family who currently has teenagers placed in their care to personally invite them to these groups.

In April, we received 1 new respite inquiry and received 1 new application for respite care. We received 1 new inquiry for general foster care of teenagers and 2 applications for general foster care. One of these applications we received is bilingual and is interested in providing care for youth identifying as LGBTQIA2S+. This month we received 1 adoption inquiry.

**District 7** 

Coos, Curry

#### Vision:

Oregon has an abundance of safe, diverse, and affirming resource families, that reflect the diversity of children, youth and young adults in foster care and are supported and equipped to meet their unique needs within their communities.

This month the champion team came together in Salem for an academy where we were able to learn more about the Oregon Child Abuse Hotline team, the Every Child Oregon customer experience team and hear presentations from an ODHS data analyst and social media manager, which will help inform our work as we track trends and launch our new ODHS social media pages. Staff took part in the Coos County Child Abuse Prevention conference. Guest speakers from multidisciplinary teams shared about the great work they are doing, including our own ODHS Interim Program Manager, Ashley Brainard. We also received confirmation of our Systems of Care grant being approved by the state, which was written in partnership with Waterfall Clinic. They will provide a monthly grief and loss support group for our resource parents. Stay tuned for more details!

In Coos and Curry Counties, resource families, ODHS staff and foster coalition partners began registering for our 1<sup>st</sup> annual tricounty (Douglas, Coos and Curry) resource family summer camp that will be held at Kellogg Springs in August, which is in correlation with retention goal #5 (to help ensure resource parents are appreciated and invited to connection events.) We already have nearly 100 registrations! In partnership with Every Child Coos, My Neighbor needs and blessing items continued to be fulfilled by the community (retention goal #8, to provide families with extra layers of support) and resource parents were invited to take part in the 3rd monthly Coffee Connect event (this month it was held in Bandon), which was held to provide resource parents with opportunities to connect as well as provide feedback/input (retention goal #6.)

Every Child Curry continued their weekly tutoring program and their My Neighbor program continued to thrive and fulfill needs and blessing items for Curry resource families and bio families. These events and supports are hosted and provided in correlation with retention goal #8 (to provide families with extra layers of support.)



As we gear up for event season, our district is stepping back into the community. Thanks to the combined efforts of everyone involved, we managed to run not one but two booths at Medford's Pear Blossom festival. One booth was set up at the street fair on both Friday and Saturday, while the other was at the pancake feed at the YMCA. It turned out to be quite a successful event. Each branch is collaborating with their units to assemble gift baskets, which will be raffled off to our resource families during the events. We've received an overwhelming amount of community donations this year, showing tremendous support for our families.

District 8 continues its partnership with Every Child to coordinate Foster Parent Night Out, and enrollment continued to expand. (Retention Goal #4: increasing local supports for resource families by 25%). The Champion continues the coordination with resource families who are interested in both counties. After launching the program in September, we have reached full capacity for every night each month. Jackson's FPNO is scheduled to have its last night in June, but the champion is coordinating with other members of the community to try to continue the program through the year.


In March, the district received 15 general applicant inquiries, 1 inquiry related to respite, and 0 related to adoption. 







Pear Blossom street fair in Medford.




We also continued to work on our upcoming Resource Family Appreciation event in May. We have had many generous donations from our community and have had staff come together on a committee to help with the planning of this event.





# **District 10**

Jefferson, Deschutes, Crook

Vision:

Oregon has an abundance of safe, diverse, and affirming resource families, that reflect the diversity of children, youth and young adults in foster care and are supported and equipped to meet their unique needs within their communities.

During the month of April, D10 received 6 inquiries. These consisted of 4 general foster care and 2 certified respite inquiries. All were received by phone call or walk in directly to ODHS. This month, the certification team opened 1 new general applicant provider (Recruitment Goal #3: Certify 2 families for youth ages 13-18+yrs, Recruitment Goal #4: Certify 1 resource home for sibling groups.)

D10 held the first in person respite orientation this month. Four families attended and three applications were received. Two of these families identify as Hispanic/Latino, one of which would also like to pursue general resource certification. Currently, D10 has a total of 5 certified respite providers. (Recruitment Measurable Goal #2: Identify and certify 2 Hispanic/Latino identifying general resource families by December 2024)

This month D10 held two events for resource families, a dinner and discuss and a meet up at Lil Bug Play Hub. (Retention Measurable Goal #3: Coordination of quarterly events for resource families and ODHS staff to attend together with at least 4 events planned by December 2024.)

The dinner and discuss offered an opportunity for families to earn training credits while coming together in a collaborative way. Our topic for April was out of home care assessments. Presenters included the local retention and recruitment champion, a local child protective services worker, a D10 program manager, a certification supervisor, and the D10 foster care consultant. Families received support and answers to their questions around policy and procedure.

The D10 champion continues to ensure ongoing activity #2, creation of quarterly newsletters for resource families to update them on ODHS policy changes, upcoming events and trainings, staffing changes and offer encouragement is completed to support resource families. So far, a monthly newsletter has been sent out regularly since August 2023. This newsletter includes an announcement regarding the winner of the gift card to support ongoing activity #3, supporting SSAs through transportation support tracking and appreciation for resource families assisting with this. Sending a thank you card and coffee card to one family per month. So far, we have offered gift cards to 4 families.



The Child Abuse Prevention and Awareness shirts have been a traditional of District 12 for over 5 years. Each year we select a new design to be printed on a navy-blue shirt which staff choose if they wish to purchase. We then select a specific day of the week where we all wear a blue shirt. In addition to wearing our shirts to spread awareness, we also distribute pin wheels in our communities. Our hope is to spread awareness about child abuse prevention in our local communities.

This month we hosted one of our quarterly Dinner and Discuss event. We had our foster care coordinator, Sally Vergara-Clement, as our guest. Resource parents had the opportunity to sit down with Sally and ask her questions related to policy, procedure, and our certification standards. This was a well-received event by our resource parents which sparked our next topic for upcoming dinner and discuss events which will be the life of a case. We will have a guest from each unit at upcoming dinner and discuss events to talk through their role in a case and answer questions that resource parents may have.

District 12's recruitment efforts this month consisted of attending the Morrow County Children's Fair in Heppner. This event allowed us to do outreach in more of our rural area of the county. It was a great opportunity to interact with the families of the community. In addition, we have received permission from the Pendleton School District to have our yard signs posted in their car pick up line through the end of the school year to recruit families at our local schools.

In April, we received one inquiry for general foster care and one inquiry for certified respite. Both inquiries were received from Every Child.















As part of our district retention plan, we are providing resource parents with the opportunity to gain training credits while learning valuable information in a collaborative environment. (Retention Goal #2 The agency will provide the resource parent with necessary support through Dinner and Discussions on a quarterly basis.) This quarter's dinner and discussion was held on April 25th at the Oregon City office. We had about 17 families and 25 children attend. Children had designated activities to keep them busy while resource parents learned more about Out of Home Care Assessments. Presenters included the local retention and recruitment champion, our local CPS worker who typically assesses these concerns, and our Foster Care Consultant, Sally Vergara-Clement. We were able to provide them with support, policy, and a frequently asked questions website from Every Child. Every Child PDX Associate Director, Maia Anderson, was also present and shared about the programs that they offer.


We continue to focus on respite certifications to support our resource families and families of origin. The certification team was able to help support two families with our reunification respite funds and one family case has recently closed.


The champion and Foster Care Coordinator, Sally Vergara-Clement, are planning to meet to start reviewing the district's open resource parent certifications to identify families that may have not taken any placements recently. This is going to be done to develop a list to further analyze with the certification supervisors the families that have maintained a certificate with no placement. Findings will be used to inform retention work and to identify any possible needs for the family.

District 15 received 3 general applicant inquiries and 1 adoption inquiry during the month of April. We also opened 3 new general applicant homes.

#### Vision:

Oregon has an abundance of safe, diverse, and affirming resource families, that reflect the diversity of children, youth and young adults in foster care and are supported and equipped to meet their unique needs within their communities.

In April, D16 received a total of 17 inquiries. Among these, 9 pertained to general foster care, 5 expressed interest in respite care, 2 sought information on child-specific foster care, and 1 inquiry was about adoption. We certified 1 new general applicant resource parent.

The Fostering Pride planning team organized a virtual recruitment event for LGBTQIA2S+ individuals across the state on April 16, 2024. Seventeen households participated, with attendees hailing from various regions including Portland, Albany, Salem, Roseburg, West Linn, and Eugene. Outreach has been made to the 3 registrants from Washington County who did not attend the event (recruitment strategy #3-recruit and certify caregivers from the LGBTQIA2S+ community).

Working alongside our D16 Partnership, Resource, and Outreach (PRO) Team, which includes personnel from Self-Sufficiency, Aging and People with Disabilities, and Child Welfare, we were able to attend Healthy Kids Day in Sherwood and Tigard on April 20<sup>th</sup>. This collaboration enabled us to be in two communities simultaneously, providing information about resources available through ODHS programs, including foster care and respite (ongoing recruitment activity #3 – build partnerships with schools, medical facilities, and mental health providers to share information about foster care and the respite program and recruitment goal #1 – recruit and certify individuals or families with diverse racial or cultural backgrounds).

We are strengthening our summer community outreach initiatives in collaboration with the PRO Team. Our team will be sharing details about ODHS programs and foster care at various events including the Native Youth Wellness Warriors Pow Wow in Hillsboro, Pride in Beaverton, Portland Pride (in collaboration with the Pride ERG), Latino Cultural Festival (in partnership with Every Child), and additional events (recruitment goal #1 – Recruit and certify individuals or families with diverse racial or cultural backgrounds).

The certification team is diligently organizing our second annual appreciation event for resource parents at Plumper Farms. We're currently sorting out prizes, and thanks to support from various community sponsors, the menu has been finalized.
